I am submitting a written complaint against Somaru Roy (59) S/o Lt. Sashadhar Roy of Rupsingh jote PS Bagdogra Dist. Darjeeling to the effect that today on 13.10.23 at 18-50 hrs received source information that one person was selling Liquor illegally from his house at Rupsingh jote PS Bagdogra to its customers without any valid license. Accordingly I informed the matter to the duty officer of Bagdogra PS and O.C.
