Sir,

I, SI Binup Mahato of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person Somaru Roy (59) S/o Lt. Sashadhar Roy of Rupsingh jote PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

1. Thirty nine (39) nos of sealed Bottles of Himalayan Fata Fati India india made Liquor 70 up, each bottle 300 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.

I am submitting a written complaint against Somaru Roy (59) S/o Lt. Sashadhar Roy of Rupsingh jote PS Bagdogra Dist. Darjeeling to the effect that today on 13.10.23 at 18-50 hrs received source information that one person was selling Liquor illegally from his house at Rupsingh jote PS Bagdogra to its customers without any valid license. Accordingly I informed the matter to the duty officer of Bagdogra PS and O.C. Bagdogra PS and as per his instruction myself alongwith C/851 Chandan Debnath, CV- 386 Kishor Hawlder, CV-375 Jogesh Barman VP-01 Ansalam Kujur left for Rupsingh jote to verify the veracity of information vide Bagdogra PS GDE No. 631 dt. 13.10.23. On arrival at the spot at 19-35 hrs it was found that one person mentioned above was selling liquor illegally from his house at Rupsinghjote to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above. Thereafter in presence of witnesses (1) Niranjan Roy (48) S/o Biswanath Roy of Rupsinghjote, gossainpur PS Bagdogra Dist. Darjeeling and (2) Constble No. 851 Chandan Debnath of Bagdogra PS, SPC I recovered the above noted articles from his possession from his house and seized the same as per proper seizure List and labelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. The seizure & arrest was made in between 19-35 hrs and 20-15 hrs (seizure Total approx 11.7 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Somaru Roy (59) S/o Lt. Sashadhar Roy of Rupsingh jote PS Bagdogra Dist. Darjeeling and arrange for its investigation.
