Sub - Threatening for vacating Rented House

Respected Sir,

This is to inform you that I Swati Sharma  
D/o Satish Kumar Sharma is currently residing in Jyoti  
nagar, bottle company more in a rented house since  
10 months with full consent of Landlord. I have been  
paying 11000 rent plus electricity bill since 10 months  
on every 1st date of starting month. On 1st of this  
month (Oct) I have already paid advance rent (cash)  
but suddenly today landlord 'Swampa Das Roy' and  
his brother and two unknown relatives of the same  
are forcing me to vacate the house overnight. These  
people have also threatened me to throw acid on  
my face and using slang languages which hampers the  
dignity of a girl. The man (Landlord's brother) and  
two of his relatives entered in the premises around  
8.20 pm and also forced upon and hit me and my  
fiance. They are also using too much of slang  
languages and threatening me. As we have paid advance  
for this month we just requested the landlord to give  
us few more days to vacate but they started hitting me  
and my fiance and also they have threatened that they  
will come after 10 pm today and throw everything out  
of the house.

Kindly request you to take some action as we both (me and my fiance) are feeling unsafe. They will definitely come at night to harm us. Please provide us with some safety and take strict action against them as soon as possible since they entered inside the premise the guy also tried to molest me.


