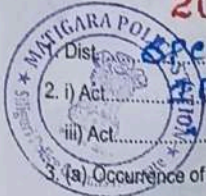

Respected Sir,

I Rina Mallick, wife of Late. Pankaj
Mallick, Resident of Vill. Rasantala, P.O. Kadamtla
PS, Matigara, Dist. Darjeeling, would like inform
you that as follows:-

1. That I am absolute owner and physical possessor
of one vacant vest land measuring 2 Kathas,
situated within the Mauja-Kalam, J.L. NO. 76,
Sheet NO. 1 LR, Plot no. 315, which was purchased
by my father-in-law Namby Anandi Mallick, son
of Late. Kashi Mallick (now deceased) from
Siman Oraon, son of Late. Mangra Oraon
(now deceased) on 19/11/1995 for an amount
3,000/- three thousand only. The said seller was
the resident of the northern side of my above
mentioned land.

2. That at present I intend to construct an tin
shed house for my residential purpose but the
family member of the seller of my residential
said land namely Sunil Oraon, his three Brothers,
all are son of Late Siman Oraon and his
mother intentionally and maliciously restraining
me and my son Prem Mallick not only from
constructing my house over my said land but
also interfering with my peaceful possession of
my said land.

3. That since month of August 2023 above Miscreants trying to engage conflict - and are trying to cause breach peace and tranquility over the said area, after the intervention of the Senior and other family members of both the parties it was unanimously settled and mutually agreed by the both parties that

(A) I shall give Rs. 10,000/- Rupees ten thousand only to the wife of Late Simaroon as a "Bakshi" for taking care of my aforesaid land all these years after the death of my father in law

and in the presence of all of them it was again reiterated and decided that I shall comply with my above mutual conditions and they shall not restrain me from any constructions but get societal result.

• I therefore, request you Honors, My be pleased to intervene in this matter and help me to enjoy my land peacefully. I shall be highly to you forever.
