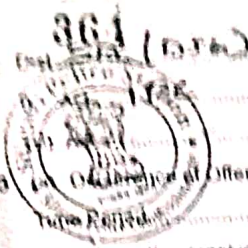

Dear Sir,

With due respect I the undersigned would like to inform you that I have appointed for installing the CCTV camera at Siliguri Police Commissionerate area by the Siliguri Jalpaiguri Development Authority, Siliguri and in connection with the same On 15.10.2023 i.e. last night my brother Sri Ranjan Routh and other staffs installing the CCTV camera at Venus More, Siliguri and one car parked there and some camera, wires and tools were inside the car. When my brother and staffs working there then one person Sri Pankaj Sha, S/o. Raju Sha, of Dangipara, Ward No. 6 of S.M.C., P.O. & P.S. Siliguri, Dist. Darjeeling and some unknown miscreants arrived therein and enquired to my brother as to by whose permission my brother installing CCTV at Venus More (Hashmi Chowk), Siliguri and when my brother and other staffs peacefully answered to them about the employing authority, started hurling over my brother in loud voice and uttering slangs in most abusive and filthy language by threatening to my brother and staffs that if my brother do not pay them the extortion amount of Rs. 1,00,000/, they will kill my brother then and there, and said Pankaj Sha also demand the key of our said car which was parked there and snatched the key from my brother's pocket and threatened to my brother and other staffs how to do the work in their area without their permission and they escaped the said place. After elapsing 5 minutes said Pankaj Sha and other 30 persons (they are local goons) came with puncher, rod, hocky stick and others weapons. Suddenly they had attacked on my brother and staffs without any reason and they hit my brother on his head, chest and face with weapon, fist and blow and they snatched of a sum of Rs.40,000/- (Rupees Forty Thousand) only from the bag of my brother and some CCTV camera took from our car and when police came at the

incident place then they flew away from the incident place. Thereafter after staffs called me and told entire incident and I went to the incident place i.e. Venus More and I was taken to my brother to Siliguri District Hospital where my brother admitted now and undergoing treatment and also stitches over upper lip of my brother and philtrum and bandages entire over my body.

Under the above circumstances I would like to request you to investigate the matter and take proper action against the accused person and do needful for the ends of justice.
