Would like to lodge a complain against LAXUMAN CHHETRI permanent resident of Kalimpong, Pedung Kagay. On 17/10/2023 at around 4pm I went to my friends house at Milan More after my college situated at Sisabari for lunch. the above named person used to eve tease me in inappropriate manner and gesture as and when I by pass him on Road, and harassed me for which I had lodged a complaint against the same person dated 25/09/23. after which the above named person was silent and was not harassing me but today at around 4pm he followed me from Maheshmari till my friend house without my knowledge. after which I felt insecure & I left from the place after 1/2 hour in To-To Rickshaw as I was coming back in To-To the above named person started chasing the toto from Milan More and started to abuse verbally abuse me and my family in public but I did not paid any heed to his comments as I reached Maheshmari, Milan More he forcefully stopped the To-To & tried to pull me

local person & shopkeepers came on the spot
and rescued me from the spot and dropped me
till my PG. the above named person continuously
was threatening me by saying me that he will
kill me if he found me anywhere outside. as
I said I will file a case against you he replied
that he has good influential people & I cannot do
anything against him.
