1. That the applicant is Kaushal Pandey son of Sri Debendra Pandey, Resident of Khudiram Pally, Dakshin Bagdogra, P.O. & P.S. Bagdogra, Dist. Darjeeling, Pin : 734014 is a law abiding and peace loving citizen of India.
2. I and Chotu Kumar Paswan have good and cordial friendly relation since long but Chotu Kumar Paswan is only a friend for money in this friendship. It is pertinent to note here Chotu Kumar Paswan always kept asking for money on one pretext or other and such as a friend I kept providing the same without much thought it is pertinent to note here Chotu Kumar Paswan always asked for cash but some of time when I was short on cash then Chotu Kumar Paswan took Payments through Phone pay, Google pay and cheque stating that though he needed cash but he will manage somehow it is pertinent to note there that the amount provided to Chotu Kumar Paswan since 2021 till 2023 through Phone pay , Google pay and cheque is not less that Rs. 2,67,000/- (Rupees two lakh sixty seven thousand only) but the total financial help extended by me to Chotu Kumar Paswan even at its minimum must be around Rs. 6,00,000/- (Rupees six lakh only).
3. It is pertinent to note here that in the month of January,2022 Chotu Kumar Paswan demanded a sum of Rs.3,00,000/- (Rupees Three Lakh Only) in cash as financial help from me but I showed my inability to provide such a large sum in cash upon that Chotu Kumar Paswan again asked the same amount through online transaction .
