Respected Sir,

I am Anita Gupta, Wife of Bijoy Prasad, Residing at Gurung Busty, Near Ram Narayan field, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, West Bengal. I like to inform you that the last night dated 18/10/2023 at about 10:30 P.M. when me and my husband talk to each other and finish our dinner my elder brother-in-law namely Ajoy Prasad, S/o Pahalad Prasad and his wife Renu Prasad suddenly enter my room and attack us with sharp weapon like knife and for the result deeply cut my husband's Right side neck and put battam which was lying down and stuck my head and Right side hand and broke down my right side wrist and at the same time my elder brother-in-law also attack my husband head and other part of body. When I shout "Bachao" then my neighbours come and rescue us and then the accused person namely Ajoy Prasad and Renu Prasad flew away from the my room. Thereafter my neighbour inform my parental house and my family member was came within 20 minutes and they were admitted me to the Siliguri District Hospital. Now I am admitted on Siliguri District Hospital dated 19/10/2023 at about 12:05 A.M. being Registration No.63857. My condition is very serious and I am fighting myself.

For the kindness please take appropriate legal action against the accused person namely Ajoy Prasad, S/o Pahalad Prasad and his wife Renu Prasad as soon as possible, my F.I.R is getting late due to my hospital admission.
