With due respect I Smt. Jyotsna Sarkar Biswas, W/O- Ajit kr. Sarkar, Resident of Tinbatti colony, ward no- 32 SMC P.O- Bhaktinagar, P.S- NJP, Dist.- Jalpaiguri - 734007, fervently appeal before your goodself to the effect that, I have purchased 2 Katha 2 chhataks land from one Smt. Alo Dutta, with the consideration of Rupees- 24,60,000.00/- (Twenty four Lakh Sixty thousand rupees) by virtue of executing a Deed of Sale being registered being no- 11419 of 2022 being book no- 1, volume no- 0711- 2022 in page no- 256629 to 256644, dated 23.12.22 and the sale deed was registered at the office of ADSR, Bhaktinagar, Jalpaiguri and the said landed property is free from all incumbrances but the above mention offenders make a forged Sale Deed being no- 06097/2023 which was duly registered ADSR, Bhaktinagar, Jalpaiguri on 12/10/2023 and on the strength of said forged document the above mention offenders and their muscle man came into the schedule landed properties of me and threatened to demolished the boundary wall failing which they will disposes us by breaking the lock of iron gate and demolished the boundary wall.

Be it mention here, the said Bimala Barman made a false Affidavit with a declaration before the Executive Magistrate, Jalpaiguri on 19.01.2021 by claim she is a only legal heir if Bhadru Singh Das, S/O- Late Baburam Singh Das and thus way she has been sold land property of me in collusion of munna Sha make a false sale deed being no- 06097/2023.

But actual fact is that after death of said Bhadru Singh Das, he has left his surviving legal heirs i.e. his wife namely Debaswari Roy and only daughter Sabita Roy. But the wife of the Said Bhadru Singh Das already passed away and at present his only daughter is alive namely Sabita Roy.

For your Kind information I have enclosed here all relevant documents on the aforesaid matter.

Therefore, considering the aforesaid facts and circumstances your high handed legal action is highly required against the above mention offenders for ends of justice.
