Respected Sir,

With due regards, I, **SRI PROSENJIT ROY CHOWDHURY**, Son of Late Pankaj Kumar Roy Chowdhury, Resident of Mangal Pandey Sarani, Ward No. 38 of Siliguri Municipal Corporation, Siliguri, P.O. Rabindra Sarani, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to lodge this written complaint before your good authority to the effect that I have two sons namely Pratik Roy Chowdhury and Pritam Roy Chowdhury. My elder son Pratik Roy Chowdhury has completed his Higher Secondary Education and after completion of his higher secondary education, he started to work in a medicine shop at Swamiji More, Siliguri.

Sir, since last few months, we have noticed some abnormal changes in the attitude and behaviour of my elder son and he was mentally depressed and inspite of our request, he did not say anything to us. He used to talk over phone throughout the night with someone and from their telephonic conversation, we could learn that he has a love and affairs with a girl namely Amisha Rajak (having Mobile No. 74792-54214) of Bagdogra since last few years and recently, said girl has started to picked up quarrel with my son in every manner and also started to threaten him with dire consequences to breakup their said relation in connivance with her some so called friends namely Amit Das (having Mobile No. 82507-23683), Kiran Pathak (having Mobile No. 97356-07957) and Sayan Roy (having Mobile No. 91443-45052) and almost everyday, the aforesaid friends of said girl namely Amisha Rajak have started to threaten my son not to keep any relation with the said girl and

also provoked and abetted my son continuously to commit suicide and we realize the said fact but my son never disclose the same to anyone inspite of our repeated request due to fear and shame.

Sir, yesterday i.e. on 17.10.2023 after completion of dinner at night, my two sons went to their respective bedrooms and in the morning, my younger son found that his elder brother is hanging with ceiling fan with a rope and seeing the said situation, he started to hue and cry and thereafter, we went to the bedroom of my elder son namely Pratik Roy Chowdhury and found that he is hanging. Immediately we brought down my said son and took him at Siliguri District Hospital where the attending Doctor declared him dead and thereafter, his body was sent to North Bengal Medical College and Hospital for post mortem examination. After the said incident, we have scrutinized the mobile phone of my deceased son and found that before committing suicide, my said son has posted a suicidal note in the social networking site named as "Facebook" and "WhatsApp" stating inter-alia that he has compelled to commit suicide due to the continuous torture of the aforesaid persons and he also stated that the aforesaid persons are liable for causing his death as they have continuously provoked and abetted him to commit suicide.

I, therefore, request you to investigate into the matter and please take appropriate strong legal action against said (1) Amisha Rajak, (2) Amit Das, (3) Kiran Pathak and (4) Sayan Roy and others as per the provision of law and obliged thereby.
