With due respect, I am producing herewith 01 (one) arrested accused person named Biplab Ghosh (37), S/o- Lt. Suren Ch. Ghosh of Near Ghosh Nursing Home, Ward No- 35, PS-New Jalpaiguri, Dist- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 12 (Twelve) bottles of Himalayan Gold Country Spirit 60 UP country Spirit (each bottle containing 600 ml)

I, ASI Khagen Ch. Barman presently attached with NJP PS, SPC under your kind control beg to state that on 11.10.2023 during my special mobile van duty, at 14.25 hrs, I received a secret source information that one person noted as above is selling ID liquor illegally at 'MAA' Hotel, Hotel Line, NJP Rly. Station, PS- New Jalpaiguri, Dist- Jalpaiguri. Accordingly, I inform the matter to you and as per your direction, myself along with C/1044 Hari Kherwar, CV/306 Biswajit Roy all of NJP PS, SPC left for 'MAA' Hotel to work out the information in hand. At 14.35 hrs we arrived at 'MAA' Hotel and per indication by the source, I apprehended the above noted person who was selling ID liquor at the hotel. On being asked he disclosed his name and address as noted above. During raid, the persons who were buying liquor was able to fled away from the hotel. During interrogation he disclosed that he was selling ID liquor at the hotel located at Hotel Lane, NJP Rly. Station, PS- NJP, Dist- Jalpaiguri. On search in the hotel the above noted I/D liquor was recovered. On demand he failed to produce any documents/license in respect of store/sale of the I/D liquor recovered from the hotel. Accordingly, I seized the above noted I/D liquor which was found from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 14.55 hrs to 15.05 hrs on 11.10.2023.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused named Biplab Ghosh (37), S/o- Lt. Suren Ch. Ghosh of Near Ghosh Nursing Home, Ward No- 35, PS-New Jalpaiguri, Dist- Jalpaiguri and arrange for its investigation.
