Sir

With due respect. I am producing herewith 01 (one) arrested accused person named Dashrath Saha (48), S/o- Haran Ch. Saha of Michel Madhusudan Colony, Haripur, PS-New Jalpaiguri, Dist- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

- 1. 11 (eleven) bottles of Himalayan Gold Country Spirit 60 UP country Spirit (each bottle containing 600 ml.)

I ASI Dhruba Mishra, presently attached with NJP PS, SPC under your kind control beg to state that on 12.10.2023, during my special mobile van duty at NJP PS area, at about 14.45 hrs. I received a secret source information that one person as noted above is selling ID liquor illegally from his shop located at Haripur Gowalabasty, PS- New Jalpaiguri, Dist- Jalpaiguri. Accordingly, I inform the matter to you and as per your kind direction, myself along with C/453 Uttam Dey, C/152 Abdul Kayum Mia, VP/13 Jamirul Islam all of NJP PS, SPC left for Haripur Gowalabasty to work out the information in hand. At 15.15 hrs we arrived at Haripur Gowalabasty in the shop of the above noted arrested person and as per indication by the source, I apprehended the above noted person in red hand who was selling ID liquor from his shop. On being asked he disclosed his name and address as noted above. During raid, the persons who were buying liquor, were able to flee away from the shop. During interrogation he disclosed that he was selling ID liquor from his shop located at Haripur Gowalabasty for his illegal gain. On being search his shop, the above noted I/D liquor was recovered. On demand he failed to produce any documents/license in respect of store/sale of the I/D liquor which were recovered from his shop. Accordingly, I seized the above noted I/D liquor which were found from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 15.35 hrs to 15.45 hrs on 12.10.2023.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused named Dashrath Saha (48), S/o- Haran Ch Saha of Michel Madhusudan Colony, Haripur, PS-New Jalpaiguri, Dist - Jalpaiguri and arrange for its investigation.
