Sir,

In producing herewith one arrested accused person namely Khagen Roy (55yrs) S/o. Lt. Bhulu Roy of Chatkiavita, PO-Sahudangi Hat, PS-NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 14(Fourteen) sealed Bottles of Himalayan Gold 60 up country spirit, each bottle containing 600 ML.

I, ASI. Rabi Tamang of Ambari Falakata Out Post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 12.10.2023 during my raid duty vide Ambari-Falakata OP GDE No. 380, Dated: 12.10.2023 at 18:35 hrs received a source information from Chatkiavita, under Ambari Falakata OP that the above noted person has gathered huge amount of liquor illegally at his house for selling the same in the customer for his wrongful gain. Accordingly I informed to O/C Ambari Falakata Out Post about the information. As per his kind instruction I along with, (1) ASI. Uday Sankar Bhattacharjee (2) L/C-741 Mallika Roy (3) C/975 Swarup Basak all are of Ambari-Falakata OP, Under NJP PS/SPC proceeds to Chatkiavita under Ambari-Falakata OP to work out the information. At 18:55 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Chatkiavita at the house of the above noted person and recovered the above noted articles from the possession of accused person namely Khagen Roy (55yrs) S/o. Lt. Bhulu Roy of Chatkiavita, PO-Sahudangi Hat, PS-NJP, Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person in presence of witnesses. The seizure was made between 19:15 hrs to 19:35 hrs. Then I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Khagen Roy (55yrs) S/o. Lt. Bhulu Roy of Chatkiavita, PO-Sahudangi Hat, PS-NJP, Dist- Jalpaiguri under proper section of law.
