I, **Sri. Tanmoy Bal**, (Mobile no. 9832538671), aged about 33 years, S/O, Sri. Kartick Bal, r/o, ward no. 31 of S.M.C, P.O: Siliguri Bazar, P.S: New Jalpaiguri, District: Jalpaiguri, Pin: 734005, begs to report you the following facts:-

1. That since 30/01/2021, my wife, Smt. Priya Bal has extra-marital affair with one Shubha Deep Mondal @ Liton, S/O, Late Subal Mondal, of Rathkhola, back side of Bapuji Primary School, P.O: Rabindra Sarani, P.S: Siliguri, District: Darjeeling, PIN: 734006 . Since then, she has been maintaining extra-marital relation with him and has been doing sexual inter-course voluntarily with him since then.
2. That so, on 11/10/2023, I filed a case / suit for judicial separation with my wife on the afore-said ground ,u/s. 10 of Hindu Marriage Act, in the Court of Ld. District Judge at Jalpaiguri, vide: Matrimonial Suit no. 586 / 2023. In that case / suit said Shubha Deep Mondal @ Liton is one of the party as Co- Respondent.

My wife and said Shubha Deep Mondal @ Liton anyhow came to know the afore-said fact of my said case/suit against them, on 11.10.23, in the afternoon from their sources.

Papai Dutta of Shaktighar Road no. 5, P.S: N.J.P, District: Jalpaiguri is constantly instigating my wife and said Shubha Deep Mondal @ Liton for doing so, and she is one of the conspirator with them in the aforesaid crime.

I, therefore, request you to kindly take necessary steps against the aforesaid 3 (three) culprits and save our lives and property from their hands.
