Sir,

I, Sucharita Sutradhar, Daughter of Late Sukumar Sutradhar, resident of Dakkhin Bharatnagar, SMC ward no. 24, near Sri Sri Nilgama Furniture, Dist.: Darjeeling, P.S.: Siliguri, Pin: 734 004, an educated & dignified citizen of Siliguri, want to inform you that Sri Sagar Majumder, son of Sanjib Majumder, resident of B-I-BA-DI Sarani, NJP, Bhaktinagar, Dist: Jalpalguri, Pin: 734 007 having mobile phone number 81670 32277, was appointed as a Junior staff under me in the month of December 2021 in my previous employing organization where I was working as Office Secretary. With a small number of staff strength we used to work together in a friendly environment there in my previous organization.

Seeing the unmindful behavior of Sagar due to his unsettled family condition, which he had shared with other staff including me part by part during working together, and considering his junior age & limitation of educational background, I felt sympathy on the boy. Even, in several occasions I had suppressed his mistakes in the official work from my higher authorities with the intension to save his job so that he could protect his family from financial distress.

In due course of time, Sagar resigned from the job in the month of August, 2022. I, too, resigned from the job in the month of February, 2023 and joined service in another reputed company at Dabgram Industrial park, Satellite Township, Dist: Jalpalguri.

Sagar used to contact me over telephone and used to meet me occasionally seeking my elderly advice in the matter of his then job in a separate organization and regarding his family.

But, when I perceived that he started living in a fool's paradise interpreting my soft behavior and sympathetic attitude towards him in other way and when he tried to say something else to me regarding our relation, I was astonished seeing his audacity at first. Then immediately I warned him with the message that I would not like to hear this rubbish talk further and eventually I blocked his phone number and told him rudely not to try to meet me further.

I think, he didn't stop to live in fool's paradise.

On 11<sup>th</sup> Sept. 2023 at about 12:30 AM (mid night of 10<sup>th</sup> Sept. 2023), he came in front of my residence in drunken condition and started shouting using filthy languages indicating me and my family members for the purpose of defame us. At first, we became puzzled by such unruly behavior of Sagar and then tried to talk with him. But, at that time he did not have any sense to listen anything. He was abusing indecent language and making the mid night atmosphere unsettling just like a rude person. Having been found no other way, we sought police interference from Siliguri PS. Siliguri PS immediately responded and sent police van on the spot. Seeing the police van, Sagar ran away from the spot. Somehow mother and elder sister of Sagar were present on the spot. The visiting police officers warned them with the ultimatum that if recurrence of today's situation happens further in future, Sagar will be in a big trouble.

We thought Sagar would stop such erratic behavior in future. But, proving our assumption wrong, Sagar took another unethical way and started keeping watch on my residence to know my movements and started following me everywhere. On the way to follow me at the time of going to my office at Dabgram Industrial park, he started to threaten me by giving me warning for my severe consequence using filthy language. A number of times during last 2-3 weeks, he stood in my way on the road near Dabgram Industrial Park and near Tinbatti More and tried to assault me physically. Each time somehow I managed to escape my-self.

But, now observing his madly attitude, I am very much afraid of Sagar. I feel that he can attack on my life any time. I am feeling very much unsecured during travelling to my office and during going to market or other work.

In the above circumstances, I would like to request you to please look into the matter and take suitable legal action against Sagar Majumder so that my safety & security and my free movement in the society can be assured.
