Respected Sir/Madam,

I Smt. Priya Bal, Wife of Tanmoy Bal, Resident of 5 No. Shree Pally, Kathaltala, Siliguri Bazar, Ward No. 31 of S.M.C., Siliguri Bazar, P.S. Bhaktinagar, Dist. Jalpaiguri, West Bengal at present residing at Deshbandhu Para, Gopal More, Ward No. 30 of S.M.C., P.O. Siliguri Town, P.S. Siliguri, Dist. Darjeeling, Pin - 734004, West Bengal, do hereby lodge this written Complaint against my husband namely Sri Tanmoy Bal, Son of Kartick Bal and my in law's, father-in-law namely Sri Kartick Bal, mother-in-law namely Smt. Manju Bal, sister-in-law namely Taniya Bal (Unmarried) all are resident of 5 No. Shree Pally, Kathaltala, Ward No. 31 of S.M.C., Siliguri Bazar, P.S. Bhaktinagar, Dist. Jalpaiguri, West Bengal to the effect that my marriage was solemnized according to the Hindu rites and customs at Sevoke Kalibari on 30th May, 2016 in presence of family friends and relatives of both the parties. At the time of marriage valuable furniture's, ornaments and cash also given as per demand of my in-law's. Soon after the marriage my husband took me with him in my matrimonial house and resided together as husband and wife. After the passing of one month of marriage, I became pregnant. At the time of pregnancy I was not provided with proper food and medication in my in-law's house; in lieu of that my husband and his family members used to abuse me in filthy and offensive languages because the marriage was a love marriage and not performed as per the wish of the family members. As the marriage was love marriage, hence I was not acceptable to my in-law's as their bride. Out of the said marriage a female child was born on 4th January, 2017 namely Miss Tulika Bal, who is present 6 (Six) years of age; By the birth of a female child, they, father-in-law, mother-in-law and sister-in-law increased the level of their torture upon me day after another as my husband and in-law's wanted a male child from me. It is pertinent to mention that my husband has illicit relationship with Smt. Tuli (Surname unknown) of Laketown - prior to my marriage and in still in relationship with the said lady. When I protested against said illicit relationship, I was threatened by my husband with dire consequences if I ever disclose the said fact to anyone. My husband and in-law's used to beat me and my

minor daughter with fists and blows and confined in a room under lock and keys without any food or water for whole night. Expecting for happy conjugal life I tolerated everything without opening my mouth.

Lastly on 11/10/2023, i.e., Wednesday at about 11:00 P.M. in the night I was driven out from my matrimonial home, after assaulting me by holding my hair and neck by my husband namely Tanmoy Bal, father-in-law namely Kartick Bal, mother-in-law namely Manju Bal and sister-in-law Taniya Bal and other relatives of my in law's.

They also kept my minor daughter with them and in the night hour I raised hue and cry and asking for help but no one come forward form the neighbours to raise any protest against said in human acts and activities of the husband and in-law's.

In the said dark night I was compelled to leave my matrimonial home and I alone anyhow reached my sister's house at night on 12.30 A.M. to Gopal More, Deshbandhu Para, Siliguri on foot.

I also come to know that my husband and in-law's have kept my minor daughter in the house of the one of a friend of my husband so that I cannot meet with my daughter since, the day, I was not allowed to meet with my minor daughter by my husband and in-law's

I, therefore request you to take necessary legal action against my husband namely Tanmoy Bal, father-in-law namely Kartick Bal, mother-in-law namely Manju Bal and sister-in-law Taniya Bal & relatives and also to recover my minor daughter from their unlawful custody as soon as possible.
