Sir,

With due respect, I am producing herewith 01 (one) arrested accused person named Smt. Munni Yadav (F/45), W/o- Dashrath Saha of Haripur Gowalabasty, PS-New Jalpaiguri, Dist- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 07 (seven) bottles of SAKI Country Spirit 80 UP (each bottle containing 300 ml).
2. 07 (seven) bottles of Himalayan Gold Country Spirit 60 UP (each bottle containing 600 ml).

I, SI Shib Sankar Das, presently attached with NJP PS, SPC under your kind control beg to state that on 16.10.2023, during my special mobile van duty at NJP PS area, at about 14.05 hrs, I received a secret source information that one person as noted above is selling ID liquor illegally from his house located at Haripur Gowalabasty, PS- New Jalpaiguri, Dist- Jalpaiguri. Accordingly, I inform the matter to you and as per your kind direction, myself along with C/152 Abdul Kayum Mia, C/453 Uttam Dey with ladies force of NJP PS, SPC left PS for Haripur Gowalabasty to work out the information in hand Ref. NJP PS GDE No. 753, Dated- 16.10.23. At 14.35 hrs we arrived at Haripur Gowalabasty in the house of the above noted arrested person and as per indication by the source, I apprehended the above noted person with the help of ladies force in red hand who was selling ID liquor from her house. On being asked she disclosed her name and address as noted above. During raid, the persons who were buying liquor were able to flee away from the house of the accused person. During interrogation she disclosed that she is selling ID liquor from her house located at Haripur Gowalabasty, PS- NJP, Dist- Jalpaiguri for her illegal gain. On being search her house, the above noted I/D liquor was recovered. On demand she failed to produce any documents/license in respect of store/sale of the I/D liquor which were recovered from her house. Accordingly, I seized the above noted I/D liquor which were found from her possession under proper seizure list and arrested her under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 14.45 hrs to 15.05 hrs on 16.10.2023.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused named Smt. Munni Yadav (F/45), W/o- Dashrath Saha of Haripur Gowalabasty, PS-New Jalpaiguri, Dist- Jalpaiguri and arrange for its investigation.
