SUB:- LODGING OF FIR

On 15.10.2023 a specific source info led to an apprehension of 01 Indian national & seizure of 03 Nosin AOR of BOP Fulbari Ex- 176 Bn.

In which at about 2225 Hrs, No- 170803106 CI Subrato Sarkar (Spot sentry) and deployed at 1st Shift ACP duty in the AOR of BOP Fulbari. No- 170803106 CI Subrato Sarkar (Spot sentry) and No 049440003 CI Md Ashraf who was deployed in flanking ACP Point observed some suspicious movement of 04 smugglers/miscreants with cattle heads near IBB Road (BFL Pole No. 10-11). They came from Village Kelangini side with intention to cross through GIN-231. Spot sentry immediately informed other ACP members and rushed towards the spot & challenged the smugglers/Miscreants to stop. They ran away from the spot towards India side and one smuggler/miscreant escaped and entered in village Champatgach and hid in paddy field. Villagers of Champatgach heard the commotion, they also searched the area and nabbed him. By the time BSF party arrived the villagers have already thrashed the miscreant. BSF party retrieved the injured miscreant from village Champatgach and provided medical treatment. BSF party also recovered Indian currency Rs. 100/-, 02 Nos Cow deshi 8222 x 02 worth- Rs.16444/- and 01 Bangali origin medium size cattle worth Rs.14459 (G/Total-30903/-).

As revealed by apprehended person, following Indian smugglers were involved in the above incident-

1. Harun Rashid (age-27 years) S/O MD Mustafa, Vill-Sardarpara, PO-Nakugach, PS-Rajganj (Ref your FIR No. 934/23, dated-26.09.23, FIR No. 874/23, dated-09.09.23 831/23 dated-28.08.23)
2. MD Jaffar Ali (age-35 years) S/O Moglesher Rahaman, Vill- Gugrivilla, PO-Nakugach, PS-Rajganj
3. MD Malik (age-28 years) Vill- Radhabari, PO-Nakugach, PS-Rajganj.

It is to mention here that the above mentioned miscreants earlier also involved in various illegal activities and trans-border crimes and BSF has lodged many complaints against them.

In view of the above, you are requested to lodge a FIR against the above mentioned miscreant and take a stern action against them. It is also requested to provide the copy of the FIR and intimate the outcome of the case to the Coy accordingly.
