**Sub: Complaint against the physical assault, Abuse and Trespassing.**

Respected Sir / Madam,

With due respect and humble submission, I Vishakha Gupta Resident of Ward No. 35, Bhaktinagar, New Jalpaiguri Station Road, Siliguri District Jalpaiguri, Pin- 734007, would like to inform you the following incident occurred on 15<sup>th</sup> October 2023 at approx. 4:40 PM.

That on dated 15<sup>th</sup> October 2023 A Receiver appointed by I.d. Court (Jalpaiguri) has come for inspection and identification of the suit property. The suit property is in dispute and a civil case TS 147/21 is pending before the CIVIL JUDGE, Sr. Division, Jalpaiguri. After the inspection of the said property the following named person namely (1) Madhukar Prasad Gupta, (2) Meera Gupta (3) Kritika Gupta have tried to forcibly enter into my house by physically assaulting me and damaged my property..

Further, it has become a regular habit for the above-named person to abuse, physical assault, mental torture, and life threatening on regular basis. They regularly come to NJP along with family members with other stranger person and thereby threaten us to kill.

Since the day of family dispute (i.e in the year July, 2021) they have been continuously harassing and mentally torturing my entire family by filing false F.I.R against me and my family members in Gangtok (Sikkim), Ballia (Uttar Pradesh), Siliguri (West Bengal)

Therefore, in the light of the above you are requested to register an F.I.R and take necessary action against the above-named persons.
