Sir
I, Sri Aktar Sardar (27), S/O Late Abdul Jabbar Sardar, Station Manager attached to Fulbarihat C.C.C under P.S NJP, District: Jalpaiguri, empowered by the Electricity Act 2003 (Amendment Act 2007), hereby lodge this complaint against Mr. Khokon Roy, S/O Mr. Radha Ramon Roy, and Mr. Radha Ramon Roy, residing at Haricharanvita, for the violation of U/S 135/1/E and U/S 150 of the Electricity Act 2003, as stated below.

On the afternoon of 16.10.2023, I, accompanied by my staff, including Mr. Srikanta Chakraborty (35), S/O Mr. Nihar Chakraborty, holding the designation of J.E (E) Grade-II, and Mr. Suranjit Sarkar (41), S/O Late Paran Chandra Sarkar, working as a lineman attached to Fulbarihat C.C.C, WBSEDCL, and the S&LP Team of Jalpaiguri Region, conducted a raid and inspection of the premises of Mr. Khokon Roy in Haricharanvita.

During the inspection, it was discovered that the said consumer extended his service line into a previously disconnected premises, with ID-400528447, named Radharaman Roy, without proper authorization. Khokon Roy, S/O Radha Ramon Roy, is accused of violating U/S 135/1/E, and Radha Raman is accused of violating U/S 150 of the Electricity Act 2003, in accordance with the Amendment Act 2007. I prepared an inspection memo at 3 pm and disconnected the electric connection. Mr. Khokon Roy's representative has acknowledged this by signing the inspection copy.

I kindly request that you take the necessary action in this matter.
