Sir,

With due respect, I am producing herewith 01 (one) arrested accused person named Ratan Saha (30), S/o- Dinkatu Saha of Jamidarpara, Gadra, PS- Rajganj, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 15 (fifteen) bottles of HIMALAYAN FATAFATI Country Spirit 70 UP (each bottle containing 300 ml).

I, ASI Dhruba Mishra, presently attached with NJP PS, SPC under your kind control beg to state that on 17.10.2023, during my special mobile van duty at NJP PS area, at about 16.05 hrs, I received a secret source information that one person as noted above was carrying ID liquor illegally at Murder More. Accordingly, I inform the matter to you and as per your kind direction, myself along with C/1044 Hari Kherwar, C/453 Uttam Dey all of NJP PS, SPC left for Murder More to work out the information in hand Ref. NJP PS GDE No. 804, Dated- 17.10.23. At 16.35 hrs we arrived at Murder More and as per indication by the source, found that the said person was waiting for bus at Murder More with a nylon bag in his hand. Accordingly, I apprehended the above noted person in red hand who was carrying ID liquor to his home with a view to sell the liquor to his locality for his illegal gain. On being asked he disclosed his name and address as noted above. During interrogation he disclosed that he is selling ID liquor from his house located at Jamidarpara, Gadra, PS- Rajganj, Dist- Jalpaiguri for his illegal gain. On being search the bag which was in his hand, the above noted I/D liquor was recovered. On demand he failed to produce any documents/license in respect of store/sale/carry of the I/D liquor which were recovered from his possession. Accordingly, I seized the above noted I/D liquor which were found from his possession under proper seizure list and arrested her under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 16.45 hrs to 17.05 hrs on 17.10.2023.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused named Ratan Saha (30), S/o- Dinkatu Saha of Jamidarpara, Gadra, PS- Rajganj, Dist.- Jalpaiguri and arrange for its investigation.
