Sir,

With due respect I, **SMT. SUNANDA DEY CHOWDHURY**, Wife of Late Joyendra Nath Dey Chowdhury, Resident of Buddhadeb Basu Road, Ashrampara, Post Office & Police Station Siliguri, District Darjeeling (W.B.) Pin - 734001, would like to submit and state as follows :

1. That I am an old and aged widow aged about 74 years and my husband died on 02.02.2021. I have one son, namely Sri Subhankar Dey Chowdhury and 2 (Two) Daughters, namely Kakoli Kundu (Dey Chowdhury) and Rakhi Paul Chowdhury.
2. That since the demise of my husband I have been living with my son and his family at the above mentioned address and he is now looking all my requirements and needs.
3. That my elder daughter, Kakoli Kundu (Dey Chowdhury) is a quarrelsome and headstrong lady and has a very greedy and cunning nature. She had a very bad relationship with her husband and my family and had been harassing me, my deceased husband, my son and my other daughter in various ways. She also could not stay with her husband and ultimately got divorce from him.
4. That my said daughter namely Kakoli Kundu (Dey Chowdhury) had all along been disturbing me and my husband and my husband had also sworn affidavit and published in newspaper that he had no relation with the said Kakoli Kundu (Dey Chowdhury). The said Kakoli Kundu (Dey Chowdhury) had also on number of occasions lodged false complaints against my son, my daughter-in-law, my another daughter, namely Rakhi Paul Chowdhury and my son-in-law, Debobrata Paul Chowdhury on some false and concocted grounds and those complaints were ultimately rejected by the concerned authorities.

5. That recently the said Kakoli Kundu (Dey Chowdhury) had again started disturbing me and my son and other family members in various ways, including lodging false complaints with various authorities and also labelling some false and fictitious allegations.
6. That the present whereabouts of the Kakoli Kundu (Dey Chowdhury) is not known. Her actual permanent address is C/O. Bapi Chakraborty, 17/5, Sashapur Colony (East), Trikon Park, Behind Gupta Restaurant (Vivekananda Park), New Alipore, Kolkata - 700053 and has her Mobile No. **9007026274, 9903058874, 9007665230** and she also used to call me from the said numbers on numerous occasions and have been threatening me in various ways. Although her present address of Siliguri is not known to me.
7. That on 06.10.2023, the said Kakoli Kundu (Dey Chowdhury) came to my house situated at Buddhadeb Basu Road along with 3 (Three) police personnel and alleged that there has been a theft and she had come to enquire about the same. She along with the said police personnel thereafter left the spot.
8. That after about one hour, the said Kakoli Kundu (Dey Chowdhury) again came to my house and started to shout and abuse me and my son in filthy languages. She also threatened to kill me and my son.
9. That again on 16.10.2023 Kakoli Kundu (Dey Chowdhury) came to my house and again started abusing me and my son in filthy languages and also stated that she shall kill me and my son by engaging some anti social element.
10. That having no other alternative I had to lodged a complaint with the O.C., Panitanki T.O.P. on 13.07.2021, but after lodging of the complaint, the said Kakoli Kundu (Dey Chowdhury) fled away and did not return for few months.

11. That the said Kakoli Kundu (Dey Chowdhury) had also been writing the residential address of my house as her own residential house using the said address in lodging all the complaints as mentioned above.
12. That due to such act and conduct of the said Kakoli Kundu (Dey Chowdhury), I am in a state of shock and panic and I am passing my days in apprehension of my life and the life of my son and my another daughter, Smt. Rakhi Paul Chowdhury and their family members.

In view of the above I pray before your goodself to investigate into the matter and take necessary action against the said Kakoli Kundu (Dey Chowdhury) having Molbile No. 9007026274, 9903058874, 9007665230, and do the needful in this regard.
