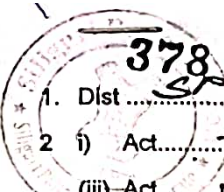

Sir, my above noted brother is very desperate & dangerous in nature and he has threatened us to kill.


So, please take necessary actions against my said brother namely, Razzak Pradhan, noted above.
