I would like to further inform you that when he purchased the phone from me and he said that he will paid the EMI and the EMI is Rs.15,650/- (Rupees Fifteen Thousand Six Hundred Fifty Rupees) only for 24 months. Then I agreed to sale the all 2nos of phone to my aforesaid friend and I hand overed the aforesaid phone to said Tirtha Biswas at near my house i.e., Janat Nagar, Ward No. 44 of S.M.C., P.S. Bhaktinagar, Dist. Jalpaiguri, on 17/01/2023. There after he paid 6 no's of EMI out of 24 no's of EMI. After paying 6 no's of EMI he stop paying EMI to my account. When I asked him to pay the EMI he refused to pay and he said that he could not pay any EMI and also said that I could not take any step against him for that. Till now he has running & enjoying the all phone.

That I would like to further inform you that my financial situation is not so good and I could not pay the EMI. For that reason Bank created

pressure upon me to pay the EMI. Now I am suffering for him as because he cheated me.

Under the above circumstances it is humble payer that you kindly take legal action against TIRTHA BISWAS for breach of trust, cheated me and his illegal act, and it is my humble request to you kindly find out my above said phones and handed over to me of my said phones for the ends of justice.
