In producing herewith one accused person namely Suresh Rana (55 yrs) S/o Lt. Jagbir Rana of Bhanu Nagar, Ward No. 43, PS- Bhakti Nagar, Dist- Jalpaiguri along with following articles under proper seizure list-

- 1] 14 (Fourteen) bottles of Tuborg Strong Beer (Each bottle containing 650 ml)
- 2] 18 (Eighteen) bottles of Kingfisher Strong Beer (Each bottle containing 650 ml)
- 3] 04 (Four) bottles of Howard's Beer (Each bottle containing 650 ml)
- 4] 10 (Ten) bottles of Impereal Blue whisky (Each bottle containing 180 ml)
- 5] 06 (Six) bottles of Mac Dowell No-1 Rum (Each bottle containing 180 ml)
- 6] 06 (Six) bottles of Budweiser Beer (Each bottle containing 650 ml)


I, ASI Dipak Karmakar S/o-Lt. Dulal Karmakar of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely Suresh Rana to the effect that on 21/10/2023 at night hrs while performing my night mobile duty, received a source information that one person is selling liquor in his hotel as style as "Purni Hotel" situated at upper Bhanu Nagar, Near Bishal Cinema Hall under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with officers and force- SI Mrinal Basunia, ASI Chandra Prakash Adhikary, C/374 Debraj Biswas had been to the said hotel to verify the veracity of the information. This refers to Bhaktinagar PS GDE entry no. 1050 dated-21/10/2023. On reaching there and as identified by the source it found that one person was selling and storing liquor in his hotel. Subsequently, I along with officers and force cordoned his hotel and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted bottles of liquor were found in his hotel. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 03(three) months for his illegal gain. Then I seized the above mentioned liquor under proper seizure list in presence of available witnesses. The whole process of seizure has been made in between 00.05 hrs to 00.35 hrs at the spot. As he has violated the rules and norms of Bengal Excise Act, hence I arrested the apprehended accused person namely Suresh Rana (55 yrs) S/o Lt. Jagbir Rana of Bhanu Nagar, Ward No. 43, PS- Bhakti Nagar, Dist- Jalpaiguri after observing all sorts of formalities u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiate against Suresh Rana (55 yrs) S/o Lt. Jagbir Rana of Bhanu Nagar, Ward No. 43, PS- Bhakti Nagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
