With due respect, I Jay Shankar Gupta, S/o- Deinath
Sah, resident of Bhujiapani, P.O + P.S - Bagdogra, Dist - Darjeeling,
want to state that I am a staff at Tirupati Service
Station, Gossainpur Forest Check Post. Yesterday dated
19.10.2023 at around 09:00 p.m, Dinesh Roy S/o- Lt. Jharen
Roy, resident of Tamburi, P.O + P.S - Phansidawar, Dist - Darjeeling,
who was driving an Tata Ace Vehicle (White) came to our
refilling station to refill his vehicle. He was totally in
drunk condition. He asked me to refill his vehicle
for Rs. 1120/- (one thousand one hundred twenty), But he
paid me Rs. 1080/- (one thousand eighty only), When I
asked him for remaining Rs. 30/- (Thirty only), he asked
me to pay him back Rs. 80/- (Eighty only) and started
quarrelling with me. He even hit me fiercely, for which
I fell into the ground and lost senses. After a while
when I regained senses, he threatened me to kill me.
This is not the first time, he has done this things many
times before as well. He also abused me for being bihari.

Hence I would request you to kindly investigate
into the matter and take proper legal action against
him.
