Sir,

I, Shila Chettri Limbu, D/o Man Kumar Chettri, W/O Dewan Limbu Vill. Chowpukuria, Dhema Chhat, P.O. - Chowpukuria P.S. Bagdogra, Dist. Darjeeling. do hereby begs to state as follows:

1. That I had married with Dewan Limbu, son of Late Krishna Bahdur Limbu, of Vill. Chowpukuria, Dhema P.O. & P.S. Bagdogra, Dist. Darjeeling, on 08.08.2008 as per Hindu Rites & customs at Chowpukuria, P.O. & P.S. Bagdogra, Dist. Darjeeling and thereafter my marriage was registered before the ADSR Bagdogra Office according to Hindu Marriage Act.1955.

2. That at the time of social marriage, my father gave many valuable articles like gold ornaments, furniture, fixtures, clothing, Washing Machine, LCD, Showcase, Wooden Dining Table, Almirah etc. and other valuable articles were given by my father and our nearest relatives which are like "Stridhan Properties" and all that articles were kept by the accused person. That out of the wedlock we have a female child namely, Kristi Limbu and male Child Dibas Limbu.

3. That after marriage we began to start our marital life on my in laws house with my in -laws at my above mentioned matrimonial house. That soon after the marriage after 2- 3 years later my husband Dewan Limbu started torturing me both physically & mentally on simple family matters. That the said Dewan Limbu is a habitual drunker and on every night he used to come home at late night and torture me for doing simple reasons and pressurised me to earn money for him even my brother in law (Dilip Limbu) and my Sister in law (Shali Gurung) and another Sister in law namely Radhika Rai who is residing at Teesta Velly also torture me and very recent time they asked for demanded a sum of Rs. 2,00,000/- (Rupees Two Lakh) only from my father for their repairing the house of my Sister in law house at Teesta Velly and when I denied

my husband and In laws increase their torture which is unbearable and I used to such type of torture for the sake of my future life and my husband and brother in law and Sister in law are force me take financial help from my father in their personal purpose .

4. That thereafter on 26.10.2023 my brother in law force fully tried to modest me by dragging my dress and he force me to divorce with my husband and also force me to do illegal relationship with him even in that event my sister in law namely Shali Gurung help him directly and when I protested against my brother in law & Sister in law for doing such illegal acts, they assaulted me mercilessly and I somehow ran away from my matrimonial house and saved.
5. That thereafter I have narrated all the facts to my father and other family members and they immediately visited their house then the husband and brother in law and Sister in law Shali Gurung became violent and assaulted my father , mother and two sister even the Dewan Limbu, Dilip Limbu tried modest my Sister Sabina Chhetri & Sima Chhetri by way of pulled by hair and assaulted my father & mother with a Bamboo and some weapons.
6. That at present I am residing at my father's house and the said Dewan Limbu and the above named in laws are continuously threatening over phone if I take a shelter then they will be take necessary action against me . That the said Dewan Limbu and his associates are dangerous in nature and character and I am very much afraid that they shall harm me and my family.

Sir, I therefore request you to look into the matter and take necessary legal action against the said Dewan Limbu and my in laws and punish them according to law for the ends of Justice.
