In producing herewith one arrested accused person namely Samrat Mallick 38yrs s/o Late Suraj Ch Mallick of Baribhasa near Ram Krishna Mini Market PS, NJP Dist, Jalpaiguri along with seized the following articles viz,

- i) 14 (Fourteen) bottles Himalayan Gold Country Sprit each bottle content 600 ML, MRP Rs, 155/= Total Rs, 2170/=
- ii) One Nylon Bag.


I ASI Anupam Roy of Siliguri PS, under Siliguri Police Commissionerate do hereby lodge this written complaint against the 01(one) arrested accused person namely Samrat Mallick 38yrs to the effect that on 27.10.2023 at night, I along with force namely C/1010 Dilip Barman CV, 513 Rajib Barman was detailed for K-21 night mobile van duty under Siliguri PS, area vide Siliguri PS, MCC No 346/23 Dtd, 27.10.2023 in course of my duty around 21.15 hrs, I received my reliable source information that one person is selling illicit liquor from his shop at Fuleswari area. Accordingly, I informed the mater to IC Siliguri PS, and as per his kind direction I along with force attend at Fuleswari area parked the police vehicle in a considerable distance and source identified the shop styled as "Dutta Restaurant" then we cordon the shop seeing the police team some customers flee away to run from the shop then we apprehended one person on interrogation he disclosed his identity as Samrat Mallick 38yrs s/o Late Suraj Ch Mallick of Baribhasa near Ram Krishna Mini Market PS, NJP Dist, Jalpaiguri and on search his shop the following illicit liquors had been recovered ie 14 (Fourteen) bottles Himalayan Gold Country Sprit each bottle content 600 ML. On demand he failed to produce any valid documents or license on support of possessing and selling of illicit liquors on his shop. On repeated interrogation he admitted that since long he worked on the shop as monthly salary basis under the direction of Sri Bimal Dutta who is the owner of the said restaurant. Accordingly, I seized the above noted 14 (Fourteen) bottles Himalayan Gold Country Sprit each bottle content 600 ML, MRP Rs, 155/= Total Rs, 2170/= under proper seizure list in presence of witness and Marked as Exhibit -A and one bottle taken as sample for examination and Marked as Exhibit -A-1 and arrest him u/s 41 of CrPC. The seizure was made from 21.25 hrs to 22.05 hrs.

Therefore, I pray before you a specific case has been started against arrested accused Samrat Mallick 38yrs s/o Late Suraj Ch Mallick of Baribhasa near Ram Krishna Mini Market PS, NJP Dist, Jalpaiguri and shop owner Sri Bimal Dutta under proper section of law and arrange for its investigation.
