I, Aishwarya Ghosh, Daughter of: Uday Sankar Ghosh, Permanent Address: Ward No. 28, Institute Colony, Siliguri, P.O & P.S- Siliguri, Dist- Darjeeling, Pin-734004, Present Address: Deshbandhu Para, P.O & P.S- Siliguri, Dist- Darjeeling, want to lodge a complaint against Akash Mallick and his friend Raj nickname Pavel, Fathers name and address unknown. The incident occurred on at Hashtag (pub), which is situated within your jurisdiction. That today on 24/10/2023, at approximately 12:10 a.m., my friends and I, who are regular patrons of Hashtag, were celebrating our puja vacation at the establishment. During our celebration, near about 2.30 a.m, Akash Mallick and Raj (Pavel) used abusive language towards us. When we requested them to cease this behavior, they suddenly physically assaulted my friend, Subhamoy Chakraborty, son of Amitana Chakraborty, resident of- Ward No. 29, Deshbandhu Para, P.O & P.S- Siliguri, Dist- Darjeeling, Pin-734004. Subhamoy sustained injuries as a result of their continuous assault.

As we attempted to intervene and stop the assault, they also touched my body inappropriately and tried to snatch my purse. In fear for our safety, we left the premises and sought medical treatment at Siliguri District Hospital. To our further distress, at around 1:30 p.m., Akash Mallick and Raj (Pavel) called Subhamoy's

mobile phone and continued to threaten us, causing us severe mental distress and fear.

I respectfully request the concerned authorities to take immediate and decisive action against Akash Mallick and Raj (Pavel). We fear for our safety and well-being and seek justice in this matter.
