Sir,

In Producing herewith two (02) accused persons namely (1) Binod Sahu (28) S/O Gorak Prasad Sahu of Debidanga Bazar, Near Church PS Pradhan Nagar Dist. Darjeeling (2) Mintu Kumar Mahato (25) S/O Upendar Mahato of Debidanga Kolabari PS Pradhan Nagar Dist. Darjeeling under arrest and seizure list and seized articles, as noted below: -

1. One vehicle bearing regd no. WB 73 E/ 9215. (TATA AC)
2. 45(Fourty five) Cartoon DABUR TOOTH PASTE, each Cartoon Containing 144 pices,each pice containing 37 Grms,MRP Rs-20/ ,Batch code-BT01615(C10)/(A10)/(A11)(Total- 6480 pices & Amount Rs 129600/-).
3. 23(Twenty three) Cartoon DABUR TOOTH PASTE, each Cartoon Containing 36 pices,each pice containing 200 Grms,MRP Rs-125/-, Batch code-BT01607(Total- 828 pices & Amount Rs 103500/-).
4. 05(Five) Cartoon DABUR TOOTH PASTE, each Cartoon Containing 312 pices,each pice containing 16 Grms,MRP Rs-10/-,Batch code-BT1642(C10)(Total- 1560 pices & Amount Rs 15600/).

I ASI Sumit Baran Nath of Ashighar OP under Bhaktinagar PS beg to lodge a written complaint against the above drivers & helper of vehicle no. WB 73 E/ 9215 namely (1) Binod Sahu (28) S/O Gorak Prasad Sahu of Debidanga Bazar, near Church PS Pradhannagar Dist. Darjeeling and (2) Mintu Kumar Mahato (25) S/O Upendar Mahato of Debidanga Kolabari PS Pradhan Nagar Dist. Darjeeling, to the effect that on 27.10.2023 at 07.55 hrs I along with C/973 Kushal Roy & CV/307 Ful Kumar Barman detailed for performing morning mobile van duty vide MCC No.1385/23 Dated 27.10.23. In course of my morning mobile Van duty at about 12.15 hrs,I received a telephonic information that one suspicious loaded vehicle detained by some persons at Purba Vivakananda Pally, ward no. 38, SMC. Accordingly, I informed the matter to O/C Ashighar OP over mobile phone and as per his kind direction, I along with force left for Purba Vivakananda Pally, ward no. 38, SMC, to workout the information. We arrived at Purba Vivakananda Pally, ward no. 38, SMC, at around 12.45 hrs and found that two persons namely (1) Debraj Pal (45) S/O Radha Gobinda Pal of 18 East Vivakananada Pally PO Rabindra Sarani PS Siliguri Dist. Darjeeling and (2) Kartick Pal (43) S/O Late Radha Gobinda Pal of do, those are introduce themselves as stockiest of Dabur India Ltd, detained one vehicle bearing registration no. WB 73 E/ 9215 loaded some products of Dabur India Ltd. Also found the above noted accused persons namely Binod Sahu and Mintu Kumar Mahato, inside the vehicle, those are identified themselves as driver and helper of above vehicle. On being asked, the above noted accused persons failed to produce any valid document for possessing the above articles inside their vehicle and confessed that they have procured the above noted articles fraudulently with an intention to sell the same at Siliguri area for their wrongful gain. There is sufficient reason to believe that the above noted drivers &

helper have stolen this articles from anywhere, for selling clandestinely at Siliguri area. Accordingly, I seized the above noted vehicle and articles under proper seizure list and arrest the above noted persons U/S - 41 Cr.P.C informing them the ground of arrest after issuing Memo of arrest. The search, seizure and arrest were made in between 13.05 hrs and 13.35 hrs on 27.10.23.

Under this circumstances I pray a specific case against the above noted drivers and helper of above noted vehicle may kindly be started and arrange for its investigation
