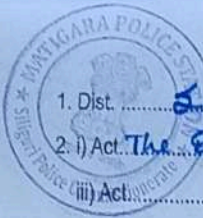

I, Sri Subhendu Chowdhury, S/O Lt. Shardendu Chowdhury, having Adhar No. 565548848198 Station Manager, Shivmandir Customer Care Centre do hereby lodge this complain to effect that Jogen Rishi S/O- Lt Bhuvan Rishi Vill. Kawakhali Rishi Basti, PO-Shushrutanagar, P.S. Matigara, Dist Darjeeling, consumer under our office having Service Consumer ID. 412100983 has committed an offence under section 135(1)(a) of Electricity Act 2003 (Amendment Act 2007) as stated here under.

On 27/10/2023 at about 12:14pm Sri Subhendu Chowdhury, S/O Lt. Shardendu Chowdhury, Station Manager, Shivmandir Customer Care Centre, Sri Surajit Chowdhury, Sr. Assistant, Shivmandir Customer Care Centre and other representative of WBSEDCL entered the premises of Jogen Rishi S/O- Lt. Bhuvan Rishi Vill. Kawakhali Rishi Basti, PO-Shushrutanagar, P.S. Matigara, Dist Darjeeling to inspect the electric installation and metering system. During inspection it was found that Jogen Rishi S/O- Lt. Bhuvan Rishi Vill. Kawakhali Rishi Basti, PO-Shushrutanagar, P.S. Matigara, Dist Darjeeling was illegally enjoying electricity for Domestic Purpose from taping the service main wire having Service Consumer ID. 412100983. The electrical load found in the premises of Jogen Rishi S/O- Lt. Bhuvan Rishi Vill. Kawakhali Rishi Basti, PO-Shushrutanagar, P.S. Matigara, Dist Darjeeling, during inspection was 1KW & declared contractual load was 1 Kw . The findings have been incorporated in the inspection report prepared by Sri. Subhendu Chowdhury, Station Manager Shivmandir CCC WBSEDCL in presence of Jogen Rishi S/O- Lt. Bhuvan Rishi and the witnesses.

As unauthorized use of electricity was detected during inspection, the illegal arrangement was removed in the presence of witnesses and the aforesaid articles were seized at the spot by preparing a seizure list duly signed by Jogen Rishi S/O- Lt. Bhuvan Rishi. Also, the existing meter, Meter No. BE0329075, Make-Bentech, (5-30)A was seized from the premises of the accused after disconnection of the said line.

Since, Jogen Rishi S/O- Lt Bhuvan Rishi Vill. Kawakhali Rishi Basti, PO-Shushrutanagar, P.S. Matigara, Dist Darjeeling, has committed an offence under section 135(1)(a) of the Electricity Act 2003 (Amendment Act 2007), you are hereby requested to take cognizance of this complain and treat this complain as FIR.
