Respected Sir,

I under sign beg to state that my father Lt. Saul Bagh was fully described owner of Plot No-532, Mouza Gourchan, Motajote, purchased in 2005, deed No-3963. After my father's death I and my sister and my mother we changed Khata in our name, Khata No-5331, 5332, 5333 and our land is a fully pucce boundary land. Yesterday around 4:30 P.M, when I went my land with some labour to clean my land with Jiblal Singha and Prabin Barman, resident of motajote, suddenly Joshep Bagh sent his local goons to the spot and started abusing me. They obstructed to enter my land and abused me while I carrying my 3 months infant. In such circumstances when my husband tried to protect me and my child, the group abused my husband, in such conditions I ran nearby to my relative brother for protection, there too he came with his people and started abusing and threatening my husband and younger sister and hit him where he broke his finger while protecting himself from his attack. In my such situation my sick sister who is under treatment in Neotia Getwell was mentally very disturbed and feel danger for her life and security.

They threatened us with words and mis-behaviours and slang languages. In these arguments my husband broke his finger and now under treatment. Today around 3 P.M. Joshey Bagh and his associates came to my residence and threatened me and my sister with abused language demanding 50 lakhs ~~₹~~ with condition of allowing us to enter peacefully in our land.

Therefore, I kindly request you to take necessary steps for our security and safety and request you to lodge this FIR as a general diary and help us with your co-operation.


