Sir,

With due respect, I am producing herewith the following articles under seizure :-

1. One truck having registration number BR 11 GC 1561 loaded with 25 (twenty five) numbers of medium size calf in various colour.

I ASI Manoj Majumdar, of NJP P.S. Siliguri Police Commissionerate, do hereby lodge this written complaint against the driver of the above noted vehicle bearing Reg. No. No. BR 11 GC 1561 to the effect that on 26-10-2023 at 07.45 hrs while I was performing night van patrolling duty under NJP PS area, with C/861 - Swapan Dhar and NVF/0068 - Amit Roy force of NJP PS, after receiving a source information, as earliest informed OC PS regarding the information, and as per his direction intercepted the above noted vehicles bearing Reg. No. BR 11 GC 1561 loaded with 25 (twenty five) numbers of oxen huddled together at Naukaghat more under New Jalpaiguri PS area which was coming from Ghosh Pukur side towards Assam but anyhow the driver of the said vehicle succeed to escape from that place. On being searched I could not found any valid documents for being possession of the cattle nor any live stock permit of the above noted oxen in the said vehicles. Even no any valid papers in r/o of the vehicle bearing Reg. No. BR 11 GC 1561 in which the oxen were loaded. It was also found that the oxen were in such manner of position causing to unnecessary pain and suffering to the cattle. Accordingly the above noted vehicle loaded with 25 (twenty five) numbers of medium size calf in various colour were seized under proper seizure list duly signed by the witnesses. It was reasonably believed that the above noted driver of the vehicle obtained the oxen either by stolen or fraudulent means as there was no any documents in support of the same nor could they indicate the source of its procurement. Then I deposited all the calf to the cowshed situated at Fulbari. Whole process of search and seizure made between 09.25 and 10.25 hrs.

Under the above fact & circumstances I fervently request you to start a case under proper section of law against the driver of the vehicle bearing Reg. No. No. BR 11 GC 1561.
