In producing herewith 03 (three) arrested accused persons namely (i) Rabindar Kr Singh (22 yrs) S/O Late Haninandan Singh of Coolipara, Ward No- 01, PS-Pradhan Nagar, Dist. Darjeeling (ii) Santosh Kamti (30 yrs) S/O Late Jhapsu Kamti of Coolipara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling and (iii) Rabi Rajbhar (25 yrs) S/O late Dinesh Rajbhar of Road No-09, Pati Colony, Ward No -47, PS- Matigara, Dist.- Darjeeling along with following seized articles viz :-

- 1) One iron made weapon called as Bhojali seized from the exclusive and conscious possession of accused Rabindar Kr Singh S/O Late Haninandan Singh of Coolipara, Ward No- 01, PS-Pradhan Nagar, Dist. Darjeeling.
- 2) One iron made sharp cutting knife and one torch light seized from the exclusive and conscious possession of accused Santosh Kamti (30 yrs) S/O Late Jhapsu Kamti of Coolipara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling.
- 3) One iron made weapon called as Bhojali seized from the exclusive and conscious possession of accused Rabi Rajbhar (25 yrs) S/O Late Dinesh Rajbhar of Road No-09, Pati Colony, Ward No -47, PS- Matigara, Dist.- Darjeeling .

I, ASI Manoj Kr Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted 03 (three) arrested accused persons namely (i) Rabindar Kr Singh (22 yrs) S/O Late Haninandan Singh of Coolipara, Ward No- 01, PS-Pradhan Nagar, Dist. Darjeeling (ii) Santosh Kamti (30 yrs) S/O Late Jhapsu Kamti of Coolipara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling and (iii) Rabi Rajbhar (25 yrs) S/O late Dinesh Rajbhar of Road No-09, Pati Colony, Ward No - 47, PS- Matigara, Dist.- Darjeeling and 09/10 others to the effect that today on 29.10.2023 at 00.05 hrs received a specific source information that 12/13 miscreants have assembled at Mahananda River Bed near Mukta Mancha under PS- Pradhan Nagar, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Bhagha Jatin Colony area. Accordingly, I informed the matter to the I/C, Pradhan Nagar PS and diarized the fact in General Diary vide Pradhan Nagar PS GDE No 1568 Dated 29.10.23 and as per order I along with ASI Biplab Kr Das, C/762 Majibul Rahaman, CV/992 Jagadish Biswas, CV/646 Baban Das, CV/242 Rakesh Monger, CV/645 Pankaj Gupta and CV/128 Ajoy Kr Sahani all of Pradhan Nagar PS, SPC, left for Mahananda River Bed near Mukta Mancha under PS- Pradhan Nagar, Dist.- Darjeeling to work out the information in hand. At about 00.25 hrs we arrived at Mahananda River Bed near Mukta Mancha under PS- Pradhan Nagar, Dist.- Darjeeling and as indicated by the source we noticed that 12/13 persons assembled at Mahananda River Bed and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 03 (three) of them with deadly weapons in their possession but 09/10 persons managed to fled away from the spot taking the advantage of darkness and open place. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally, they disclosed that they along with their associates were assembled there and making preparation for committing dacoity in a house of Bagha Jatin Colony area. On search the above noted weapon of offence recovered from their possession.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest and brought them to Pradhan Nagar PS. The search seizure and arrest made in between 00.55 hrs to 01.45 hrs on 29.10.2023.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 03 (three) arrested accused persons namely (i) Rabindar Kr Singh (22 yrs) S/O Late Haninandan Singh of Coolipara, Ward No- 01, PS-Pradhan Nagar, Dist. Darjeeling (ii) Santosh Kamti (30 yrs) S/O Late Jhapsu Kamti of Coolipara, Ward No-01, PS-Pradhan Nagar, Dist.- Darjeeling and (iii) Rabi Rajbhar (25 yrs) S/O late Dinesh Rajbhar of Road No-09, Pati Colony, Ward No -47, PS- Matigara, Dist.- Darjeeling and others 09/10 unknown persons and arrange for its investigation.
