I Umish Tamang D/O Late Kum Bahadur
Tamang residing presently at rented house at
Pradhan Nagar in Upper Bagdogra and permanent
residence at Singlibhitta, Darabagan, Naxalbar.
I would like to state as follows:

That on, 30th October 2023 (Monday) at about
2 PM Hema Kumari Tamang along with five
other persons including 2 from Nepal entered
my house in Pradhan Nagar and started threatening
me and my son Zaden Tamang to end lives if
I share any details about her with her husband
Mahendra Tamang.

That, today at around 9 am Mahendra Tamang
had come to my house to enquire about his
wife Hema's character and activities during his
stay at Army Platoon. I had told about
Hema's illicit relationship with an unknown
person.

That Hema used to visit my house
frequently and also had ~~been~~ taken some amount
of loan from me.

→

That, I knew that Hema had illicit relationship with an unknown person with whom she use to spent time in hotel and her room.

That, now Hema ~~had~~ has hired miscreants from Nepal to end life of mine and son. I fear that they might attack us at any moment of ~~the~~ time. Our lives are at risk and she had verbally threatened today that if I reveal all the truth before police or court will kidnap my son and throw him at River Mechi.

Hema seems a dangerous body as there are several criminal cases filed against her. She recently came on bail from Silliguri court.

I hereby request you to take necessary action before she commits any crime again.
