Dear Sir,

With due respect ,I, **Asha Verma**, Wife of Late Danji Prasad Verma ,resident of Gaddighar , upper bagdogra, P.O.&P.S Bagdogra, Dt. Darjeeling, would like to inform you that I am the sole absolute owner in possession of land measuring about 0.096 Acre situated at Mouza Uttarbagdogra in plot no 1601 and 1602 which is located at Gaddighar. My husband is running wine shop in and over the aforesaid land without any interruption since last 70 years. In the front side of the aforesaid land 1) Sunita devi, Wife of Late Bhanu Prasad Sah, 2) Mantu Sah and 3) Krishna Sah, both are sons of Late Bhanu Prasad Sah, resident of Notunpara, Gossainpur, P.S Bagdogra, Dt. Darjeeling forcibly occupying my land measuring 1.15 katha. In many occasions I have requested them to quit/vacate the place immediately but each and every time they are neglecting and still neglecting my request. Today morning at about 9 AM when I stepped at near our offshop I have seen our main lock of our shop room is broken by some unknown miscreants then I asked to aforesaid Sunita Debi if they have seen any stinger who entered inside our premises and did the unlawful act. After hearing the word they all became very furious started filthy languages as "**yeh buriah to iha se bhag ja nehi to jan se mar dungi**". I raised vehement objection that time they pushed me as a result I fell down on the courtyard and they started to beat me mercilessly by fist blows and kick and also torn my kurti (churidar) for the purpose of disrobing me. Listening the hue and cry local people gathered there and saved me from the aforesaid miscreants.

In this above circumstances I am requesting you to kindly investigate the above-said matter and take appropriate step against the abovesaid miscreants from my kind perusal.
