With due respect, I am Mira Tikadar Wife of Swapan Tikadar Residwnt of Santipara , P.S – NJP Police Station, Dist- Jalpaiguri, would like to inform you as follows-

That last year in Holi Festival our neighbour one Loton Dutta Son of Lt. Anil Dutta along with Pranab Dutta was had an argument with me and they were abusing me , they even hit me and gave me and my family Life threatening. After this incident they had beaten up my son two times. I live with my son who is handicap therefore we were afraid at that time and did not take any action.

But now their torture became more danger after one year again on 25/10/2023 centred on that Holi incident they came to my house and abusing me, said Loton Dutta push me on the ground again hit me and used very improper word and slang. They try kill me with the knife at that time my son namely Surojit Tikadar he came to save me , my son is handicap, he did not had one hand , therefore he was unable to protect me and himself as well. Loton and Pranab both run After my son to kill him. Somehow my son hides from them. Our life is in danger. They not only threaten us but also try to kill my son. They defame me in our locality using. They made improper offer to me and looking at me in a improper way because I live alone. They came in front of my home at night and abusing me. They tortured us mentally and physically. And now our life in danger.

That under the above mentioned circumstances I humbly pray before you to look into the matter and institute proper legal action against the accused persons.
