**SUB:- LODGING OF FIR**

It is to intimate that, On 05.10.2023 on a specific source info, No- 163501936 SI Parveen Pardhan along with SOs-02 and ORs-02 detailed for ambush and the party left BOP Fulbari at 2130 hrs for ambush.

At about 2330 hrs, the ambush party observed some suspicious movement of miscreants along with cattle in the tea garden behind IBBR in the depth area between BFL No. 13 & 14 in alignment of BP No.732/4-S in the AOR of BOP Fulbari. They were approaching towards the IBBR with the motive to smuggle cattle from India to Bangladesh. The Ambush party rushed towards the spot and challenged the advancing miscreants. On seeing the ambush party, the miscreants ran away towards village Pradhanpara by taking advantage of bad weather and darkness. Ambush party searched the area and seized 01 Bengali origin medium size cattle Rs. 14459x01 Rs 14459/- and 03 Rathi origin/ bullock Rs 10658x03 Rs-31974/- worth Rs 46433/- as outgoing/unclaimed in depth area and further handed over the seized cattle to Dhyan Foundation, Bhootnath Goushala, Kishanganj (Bihar) on 09.10.2023 .

As per the info of reliable source, following Indian smugglers were involved in the above incident-

1. Harun Rashid (age-27 years) S/O MD Mustafa, Vill-Sardarpara, PO-Nakugach, PS-Rajganj
2. MD Bukul (age-28 years ) S/O Parbasu, Vill- Bhulrivitta, PO-Nakugach, PS-Rajganj

It is to mention here that the above mentioned miscreants earlier also involved in various illegal activities and trans border crimes and BSF has lodged many complaints against them.

In view of the above, you are requested to lodge a FIR against the above mentioned miscreant and take a stern action against them. The FIR is being lodged late due to delay in receipt of documents from Dhayan foundation. It is also requested to provide the copy of the FIR and intimate the outcome of the case to the Coy accordingly.
