Sub:- Written Complaint

Respected Madam,

I, Smt. Rima Upadhyay, W/o Sri Manoj Upadhyay, D/o Uma Shankar Upadhyay, R/o S.P Mukherjee Road, khalpara, Siliguri 734005 would like to file a complaint stating as follows:-

1. That I got married to Sri Manoj Upadhyay on 16.02.2005 at Agrasen Bhawan, Khalpara, Siliguri and thereafter I used to reside at the above mentioned address along with my husband namely Sri Manoj Upadhyay and my in-laws including my mother in-law and father in-law namely Dwarika Upadhyay and Nirmala Upadhyay. That out our wedlock we also have two children namely Daksh Upadhyay aged about 13 years and Diya Upadhyay aged about 17 years old.
2. That from the starting of marriage my husband never support me financially and use to sit idle at home and he never took any kind of responsibility towards me or our kids and resorted to drinking and used to remain in a drunken state and whenever I used to stop him from drinking he used to assault me, abuse me and beat me, however I owing to my family values kept mum for the sake of my children but my husband along with his family members has become more aggressive lately, infact my husband has tried to choke me to death on a couple of occasions.
3. That after my marriage my parents use to help me financially as my husband always neglected me and his responsibilities towards me. So for providing better education to my children I started working at a law firm situated at S.P.Mukherjee Road and have been working there since last 5 to 6 years and this also did not go well with my my husband and he further tried to disturb me at my workplace also.
4. That for the past few months my husband and my in-laws have been torturing me both mentally as well as physically. It is pertinent to mention here that my husband leaves no stone unturned to beat me, even for trivial matters my husband drags me by my hair and slaps me and there have occasions where he has banged my head against the wall and this day to day scenario has left me in a state of true petrify, my husband has time and again threatened me that he will kill me someday or the other, given the present scenario I have many times thought about taking my own life but for the sake of my children I have refrained from taking any steps. That for the resolution of the dispute multiple meetings were held between our family members but the same bore no fruit.
5. That in order to save myself from this day to day torture I decided to go to my father's house located at Guru Sadar Dutta Road, South Bharatnagar, Debashis Colony,

Siliguri, Ward No- 24, for few days, but my husband did not leave me alone even there and infact he came to my father's house and created chaos everyday so much that my parents could not take it any further and I was forced to leave my father's house and move to my sister's house but my husband repeated the same there too.

6. That in order to support my family I have been working at the abovementioned law firm and when I narrated the entire incident to my employer, he out of concern offered that I stay at a flat near his residence located in laketown and handed me the keys to the said flat where I am currently residing with my children but only two days had passed and no sooner did my husband got the knowledge of the same he came there and created a ruckus too.
7. That my husband is so hell bent that he even arrived below the office where I am currently employed and started hurling abuses at me and when my colleagues tried to stop him, he even hurled abuses at them. That my husband in order to defame me has been putting all sorts of allegations against me and referring to me with derogatory terms, and further now if any person comes forward to help me, my husband alleges that I have an illicit relationship with that person and thus the entire chain of events have let me mentally bruised and further nobody wants to support me in any manner as such and I am in dilemma as to how me and my children are going to survive this daily torture.

I am now helpless and have come to your asylum with folded hands requesting you to save me from this mental and physical pain and take appropriate action against my husband and in laws. That if nothing is done to help me I shall not be able to endure this pain and survive any further and that I am also fearful that my husband at any time can cause harm to me.
