Respected Sir/Madam,

This is to inform you that I Sri. Biyanjit Saha Son of Sri. Biswajit Saha Resident of 1 no. Dabgram, Surya Nagar, p.O. Rabinra Sarani, P.S. Siliguri, Dist. Darjeeling, Pin No. 734006, would like to draw your attention that on 01/11/2023 my father was coming out from the regulated market after his work to return back at our home by his scooty bearing no. WB74BJ8869, while my father was coming out from the front gate of the said regulated market one pickup bolero (Mahindra) bearing no. WB73A8436 was coming with high speed from National highway and suddenly dashed/collided on my father's scooty and my father fell down thereon and sustained severe injuries upon his right leg and head where the right leg was fractured in the collision and operation was conducted on the said injured right leg and a metal rod has been inserted the said injured right leg.

He is now admitted in Mitra's Clinic at Hakimpara Siliguri. The accident took place due to the rash and negligence and driving of the said driver of the said pickup vehicle.

I was busy for treatment purpose of my father thus delay is caused in filing this complaint.

You are therefore requested to take immediate actions against the said pickup vehicle's driver, I will be highly obliged for the same.
