

In producing herewith two arrested accused persons namely 1. Ashok Rai (26) S/O Ashim Rai of Odlabari Tea Garden, PO-Manabari PS-Mal Bazar Dist-Jalpaiguri 2. Shankar Roy (40) S/O Lt. Jamuna Roy of Near Budha Bharati High School, Shivrampally W/no-39 PS-Bhaktinagar Dist-Jalpaiguri

I, SI Agen Lepcha of Matigara PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against the above noted accused persons and owner of the Beer Republic bar cum restaurant City Centre, Matigara, to the effect that today on 04.11.2023 at about at 02:05 hrs received an information from my reliable source that Beer Republic bar cum restaurant, City Centre, Matigara is still open and huge customers had gathered there. They are using the full sound and the customers are showing obscene act inside the Bar and outside the Bar as result local people are annoyed with the owner of the Bar, this refers to Matigara PS GDE No 168. dated 04.11.2023. Accordingly I, informed the matter to Officer Incharge of Matigara PS, SPC and as per his direction of O/C Matigara PS, SPC, Lalong with force had been to Park Park Park II.

I along with force had been to Beer Republic bar cum restaurant', City Centre, Matigara.

At about 02.15 hrs I reached at Beer Republic bar cum restaurant and I found that the Beer Republic bar cum restaurant was open and customer were dancing inside the Beer Republic bar cum restaurant and they were showing obscene dance and songs with full sound resulting annoyance of local public due to their act there are likely to cause breach of peace or disturb the public tranquility in that area. As per govt. rule and regulation the permissible time of the Bar is 23.30 hrs, but the owner of Beer Republic bar cum restaurant violated the rule of 239 of West Bengal Excise (Foreign Liquor) Rules 1998. Further I, requested to Bar manager to stop the sound and performance and to close the Bar but the manager of said Bar did not pay any heed but somehow I along with force manage to close the Bar to avoid any untoward incident. While performing the Government duty the owner of Beer Republic bar cum restaurant and others did not obeyed the lawful order promulgated by the Police team. Hence I arrested the above noted accused persons namely 1. Ashok Rai (26) S/O Ashim Rai of Odlabari Tea Garden, PO-Manabari PS-Mal Bazar Dist- Jalpaiguri 2. Shankar Roy (40) S/O Lt. Jamuna Roy of Near Budha Bharati High School, Shivrampally Ward no-39 PS-Bhaktinagar Dist- Jalpaiguri under proper memo of arrest for violating the norms of Bengal Excise Act.

I, therefore, pray before your that a specific case may kindly be started against the above noted accused persons and owner of 'Beer Republic bar cum restaurant' and arrange for its investigation.
