Dear Sir,

This is to inform you that to day morning at about 8.45 am Mr Swadesh Debnath, Chief Accounts Officer of this Centre went to 4th floor to open door of Accounts Department. On reaching there he noticed with great surprise that the steel door was open. On entering of the room, he also noticed that the glass of Cash Room door was also broken. It appears that the cash collected on 2<sup>nd</sup> November 23 and kept in steel almirah of Cash Room must have been stolen.

The theft has taken place after breaking open main door of Accounts Department took place sometime at night between 3 am and 5 am to day, ie. 3 November 2023.

The premises are covered with tall security fencing around this Centre. Two dogs are also put on whole night guarding the Centre. A good number of Staff also resides in the Centre in the near vicinity of the Accounts Department. No staff could heard any sound of breaking door, in question.

The steel almirah in which Centre cash was kept in the mentioned room, before closing of day's transaction of 2 Nov 23, was counted in the presence of Police Officials today at about 12.10 pm. It is established that there is a short fall of cash to the tune of Rs 8,33,060 (Rupees eight lakh, thirty three thousand and sixty only), which the theft has stolen from Centre.

In view of the above, it is requested to register a theft case that took place at Anandaloke Sonoscan Centre and investigate the theft case and apprehend the culprit(s), Birendra Kumar Darjee, as per CCTV footage given in attached Pen Drive for your perusal and needful action please. As per CCTV footage, culprit's Photo copy of Driving Licence No. SK04 2015 0002004, Voter ID No TBV0067769 of Birendra Kumar Darjee are also attached please. Aadhar Card No 311 5541 9051 of Deepa Sinchury, his wife is also attached.
