With due respect I Smt. Arati Dewan (Rai), W/O Subash Rai, D/O Late Amber Bahadur Dewan, residing at Methibari, Salbari Chhat Pratham Khanda, Pradhannagar, Siliguri, P.O. & P.S. Pradhannagar, Dist. Darjeeling, Pin - 734003 beg to state that I have entered into marriage with Sri Subash Rai, S/O Late Hem Chandra Rai, resident of Methibari, Salbari Chhat Pratham Khanda, Pradhannagar, Siliguri, P.O. & P.S. Pradhannagar, Dist. Darjeeling, Pin - 734003 on 8th May 2014 according to Hindu Rites & Customs and our marriage was solemnized at Panchkanya Mandir, Methibari, Siliguri. That one of my husband's aunty started the talk of our marriage and with both of our family's consent we got married.

That after marriage, me and my husband started to live together as wife and husband in his house. That after getting married we were happy with each other. My husband has mother and three married sisters in his family. My mother in law never treated me badly as I used to look after her and I took good care of her. Two of my sister in laws namely 1) Smt. Pushpa Rai, W/O Late Madan Rai, residing at our residence i.e; Methibari, Salbari Chhat Pratham Khanda, Pradhannagar, Siliguri, P.O. & P.S. Pradhannagar, Dist. Darjeeling, Pin - 734003 and 2) Jyanti Rai Rajagopalan, w/o Sri Rakesh Raja Gopalan, r/o Block- D, Sainikpuri, P.O. Khaprail, P.S. Matigara, Dist. Darjeeling- 734009, treated me in bad way since beginning of our marriage. When my sister in laws treated me badly I ignored it thinking they will change and I tried my best to make them happy. Slowly I understood the reason behind they treating me badly as my husband used to do each and every things as said by them till our marriage and they could not see us getting closer, after few weeks of our marriage I started to notice that my sister-in-laws started interfering in our married life daily. I was silent for many months thinking one day they will accept me as part of their family. After few months of our marriage my husband went abroad as he used to work in Belgium. I used to work in SSK in my paternal place and at present I am staying at my matrimonial place. My elder sister in law who resides in our home used to taunt me in everything and shouted at me daily, she even used to use filthy words and harassed me every day

with one or the other reason and she used to torture me mentally saying I did not bring any dowry at the time of our marriage and along with her my younger sister in law whenever visited our home she used to taunt me in same matter. I told my husband about these things through phone but he paid no heed to such. My husband used to send money in my younger sister in law's account and all the financial matters and decision were taken by them. My husband never tried to take my responsibility as a good husband. He used to listen to his sisters and slowly he stopped behaving properly towards me. Many times when I came from my paternal place I was being locked outside the house despite of several knocking in the gate and I had to stay in my neighbour's home as it was night time. I tried telling my husband about this he told that he will settle these issues after he will come back home.

I started feeling more worried about our marriage as my husband also started treating me badly and never supported me from escaping the mental torture, harassment done by my sister in laws. I used to be even not informed about him coming to home. His behavior changed towards me and he treated me like nobody. In the year 2021 when he again came back I was quite hopeful that he will help me out but again he took the side of his married sisters and since then I became totally hopeless regarding our marriage. After my husband returned back to his work place without any information, I was treated more worst that I was not even allowed to cook and I had to go to my relatives and friend's place to fill up my stomach. And then I was compelled to inform Gaon Samaj about all this matters. The samaj had given time to my sister in law to call my husband and settle down the matter soon. Despite of such and I too had messaged him many times but he escaped from his responsibilities and paid no heed to it. I have been going through a great mental torture because of my sister in laws and my husband who has been staying in abroad and he has been skipping from all the responsibilities as a husband.

That in the year 2022 one of known village person informed me that my sister in laws was planning to sell the resident property without my knowledge and for the same I have filed one civil suit vide O.C. Suit no. 173/2022, pending before Ld. Civil Judge Junior Division at Siliguri. The motive of my sister in laws are clear that they want to separate me from my husband and take away the property and with same nasty motives they have been harassing, torturing and threatening me to leave my house again and again.

Recently my elder sister in law namely Pushpa Rai shouted me with filthy words and slapped on my face while I was watering flowers in garden, saying I cannot touch the flowers in the garden. Both of my sister in laws even locks the

kitchen when they are together and many times I had to stay without cooking food. Said Pushpa Rai spits towards me most of the time when she sees me and use slangs with out any reason. When ever I go outside she even locks the gate and regarding this I have even informed Pradhannagar Police Station, Panchayat and Gaon Samaj about this, but till date they have not handed over duplicate key in my hand.

My husband flew abroad in the year 2021 and he changed his number and stopped making any contacts with me. I have been going through a hardships because of my husband's negligence towards me. I am suffering a lot mentally , emotionally and financially because of my said sister in laws and husband. In connection one Misc case under Domestic Violence is registered in the court of J.M. 2nd Court at Siliguri vide Misc Case no. 113/2022. My sisters in law are threatening me and trying to oust me from the residence.

So, I therefore, request you to take strong action against my husband Sri Subash Rai and his sisters namely, 1)Smt. Pushpa Rai, W/O Late Madan Rai, residing at our residence i.e; Methibari, Salbari Chhat Pratham Khanda, Pradhannagar, Siliguri, P.O. & P.S. Pradhannagar, Dist. Darjeeling, Pin – 734003 and 2) Jyanti Rai Rajagopalan, w/o Sri Rakesh Raja Gopalan, r/o Block- D, Sainikpuri, P.O. Khaprail, P.S. Matigara, Dist. Darjeeling- 734009 and initiate a case under section 498 A of IPC. And for this kindness, I shall be oblige to you.
