Respected Sir,

I, **RINKI SHOM**, W/O Rajib Some, Residing at No. 2 Panchnana, Colony P.S. & P.S. Pradhan Nagar, Dist. Darjeeling, do hereby want to inform you as follows :-

1. That I am the law abiding citizen of India.
2. That I had lodged this FIR with effect that **PROSENJIT DAS**, S/O Yadav das, and **APARNA DAS**, W/O Prosenjit Das, Resident of No. 2 anchanan Colony, ward No. 1, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, who is known to me since long time and having good family relation with me.
3. That the said **PROSENJIT DAS**, S/O Yadav das, and **APARNA DAS**, W/O Prosenjit Das in the month of October, 2022 approached before me and requested me to give around a sum of **Rs. 2,60,000/- (Rupees Two Lakh Sixty Thousand) only** as a loan as they were in a very distress condition with an assurance to return the same within few months from the date of receipt.
4. That I upon his assurance and keeping in mind of the good relation with them I gave him a sum of **Rs. 2,60,000/- (Rupees Two Lakh Sixty Thousand) only** on various dates, by taking money from various other persons.
5. That after the lapse of few months I requested the Accused Persons for the payment of the aforesaid sum but the accused persons on every occasions breaching my trust assured me to repay the said amount but with malafide intention to cheat me by way of misappropriating my money the Accused Persons didn't repay the said amount.
6. That subsequently when I started to visit to the house, the accused persons started to threat and blackmail me that if I ever dare to come to their house then accused persons will commit suicide by written suicide note in my name and will implicate me in false cases.

7. That from the last few weeks the accused persons started to blackmail me that if I want to get my aforesaid money back then I have to pay a sum of Rs. 10,00,000/- (Rupees Ten Lakhs only) to them, otherwise they will never refund my money in any condition whatsoever, rather they will implicate me in various criminal cases against me and my husband and destroy my reputation in the society which is nothing but a way of extortion.
8. That whenever I request the said **PROSENJIT DAS**, S/O Yadav das, and **APARNA DAS**, W/O Prosenjit Das to repay me the aforesaid amount of **Rs. 2,60,000/- (Rupees Two Lakh Sixty Thousand) only** the accused persons started to threaten me that they will not repay me any amount and if I ever try to meet them then I and my family member shall face dire consequences.
9. That in this way I had been cheated by the said **PROSENJIT DAS**, S/O Yadav das, and **APARNA DAS**, W/O Prosenjit Das by way of misappropriating my money which they have received from me the amount of **Rs. 2,60,000/- (Rupees Two Lakh Sixty Thousand) only**, by way of breaching my trust with an intention to cheat me by acknowledging the payment of money from me.
10. That now the said **PROSENJIT DAS**, S/O Yadav das, and **APARNA DAS**, W/O Prosenjit Das in conspiracy have made a plan to extort money from me and are also blackmailing and extorting me for demand of Rs. 10,00,000/- (Rupees Ten Lakhs only) and when I refused to give them the said amount of money, the Accused persons are constantly threatening me that they will lodged various false criminal cases incorporating false story and thereby they are trying to create pressure upon me in order to extort money putting me in fear illegally.
11. That the above named persons have therefore committed the offence of cheating and criminal breach of trust in hatching up a deep rooted conspiracy with the ulterior motive of defrauding me and causing wrongful loss to me in every aspect.

That under such circumstances, I being a pregnant and distress lady pray before you to take serious legal action against the said **PROSENJIT DAS**, S/O Yadav das, and **APARNA DAS**, W/O Prosenjit Das to repay me the aforesaid amount of **Rs. 2,60,000/- (Rupees Two Lakh Sixty Thousand) only**, which has been taken by way of breaching my trust with an intention to cheat me and put me in a condition where I have no financial capacity to secure my future life as well as to run our day to day livelihood because we are in such helpless situation where I am passing my days with tremendous hardships and the above named person by taking advantage of my distresses, succeed to cheat me.

I therefore request before your good self to kindly look into the matter and take necessary strong action against the above named persons namely **PROSENJIT DAS**, S/O Yadav das, and **APARNA DAS**, W/O Prosenjit Das as per the provision of law and for this act of kindness I shall remain extremely great full to you.
