In producing herewith 02 (two) arrested accused persons Hamely 1) Kamal Biswas (34 yrs) Sir. S/O Krishna Biswas of Chowpukuria Kestopur PO+PS Bagdogra Dist Darjeeling and ii) Ranjit Mahato (35yrs) S/O Deb Narayan Mahato of Anchal Gali no 2 Champasri PS Pradhan nagar Dist Darjeeling along with the following articles under proper seizure list. The ground of arrest duly been communicated with them.

One black color carry bag containing 150 (one hundred fifty) bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup "REXLEY-T" Cough Syrup each bottle containing 100 ml having Batch No. ML5430, Mfg date 10/23, Expiry 09/25, MRP Rs. 175/- each and marked as Exhibit "A'.

One black color carry bag containing 150 (one hundred fifty) bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup "REXLEY-T" Cough Syrup each bottle containing 100 ml having Batch No. ML5430, Mfg date 10/23, Expiry 09/25, MRP Rs. 175/- each and marked as Exhibit "B'.

One red colour motor Cycle style as Pulsar bearing registration no WB74R-9447.

l, SI Sabin Yonzon Tamang S/O. Santanbir Yonzon Tamang of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted two arrested accused persons namely i) Kamal Biswas (34 yrs) S/O Krishna Biswas of Chowpukuria Kestopur PO+PS Bagdogra Dist Darjeeling and ii) Ranjit Mahato (35yrs) S/O Deb Narayan Mahato of Anchal Gali no 2 Champasri PS Pradhan nagar Dist Darjeeling to the effect that on 04.11.23 at 14.20 hrs I, received a reliable specific source input that two persons are standing by parking their motor cycle at near Vedanta Ashram under Pradhann agar PS with huge quantity of illegal cough syrup to deliver the same to their designed customer. Accordingly, the matter was diarized in General Diary vide Pradhan Nagar PS GDE No.225 dated 04.11.23 and informed the matter to the Inspector-in-Charge, Pradhan Nagar PS in written. Subsequently, being directed by Inspector-in-Charge, Pradhan Nagar PS, SPC I along with SI Youel lepcha, ASI Mirza hossain, ASI Biplab Kr Das, C/923 Uttam Das, CV/ 649 Pancham Singha ,CV/223 Swapan Chhetri, CV/242 Rakesh Mangar,CV 128 Ajay Sahani, all of Pradhan Nagar PS, SPC left for Pradhannagar near Vedanta Ashram under Pradhann Nagar PS by Govt, vehicle with investigation kits to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No 226 Dt. 04.11.23 and M.C.C No 5082/23 dated 04.11.23. I also informed one Videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling over telephone and directed him to come Pradhannagar near Vedanta Asram under Pradhan Nagar PS with his video camera for the purpose of videography as per norms. Under these circumstances any search warrant or authorization for search cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. On the way I briefed all the police personnel and share the information in hand.

On the way to Vedanta Asram under Pradhann agar PS I contacted two independent witnesses namely (i) Puspam Kumar Ray S/o Rajendra Ray of Dharam Nagar Coolie Para W/N. 01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Shiva Pasawan S/o Shyamlal Paswan of Dharam Nagar Coolie Para W/N. 01, PS- Pradhan Nagar, Dist. Darjeeling and informed them about the source input and requested them to act as witness, if any search and seizure would be made, upon which they agreed. I also issued notice to the said independent witnesses.

After reaching at the spot and being identified and pointed by my source we apprehended two persons, parked red motor cycle style as Pulsar bearing registration No.WB74R-9447 and two black colour carry bag. Thereafter, we disclosed our identity as police personnel and informed them regarding the information in hand and stated them that they will be searched in person for the said purpose. On being asked they disclose their identity as i) Kamal Biswas (34 yrs) S/O Krishna Biswas of Chow Pukuria Kestopur PO+PS Bagdogra Dist Darjeeling and ii) Ranjit Mahato (35yrs) S/O Deb Narayan Mahato of Anchal Gali no 2 Champasri PS Pradhan nagar Dist Darjeeling.

On being asked they admitted that they have being illegally possessed cough syrup for selling the same to his designed customers as per their requirement. I, then gave them option in writing whether they wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which he agreed to be searched in presence of any one of the above. Accordingly, I informed the matter to the I/C, Pradhan Nagar PS and as per his kind order, I informed the fact to Shri Manish Kumar Yadav, WBPS, ACP Investigation unit, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day regarding interception of the accused persons suspected to be possessed illegal Codeine Phosphate' based Cough Syrup and requested him to come at near Vedanta Asram under Pradhann agar PS Dist.- Darjeeling to remain present and to supervise the search and seizure.

Accordingly at 16.05 hrs Shri Manish Kumar Yadav, WBPS, ACP Investigation unit, Siliguri Police Commissionerate arrived at the spot. Then, I offered the independent witnesses and the detained persons to search our Police Party as per provisions of law but they denied to search the police party. Thereafter, in presence of Shri Manish Kumar Yadav, WBPS, ACP Investigation unit, SPC and independent witnesses, I searched the detained persons following all formalities, keeping their strict regard of decency but found nothing except their wearing apparels but on searched I recovered one black colour carry bag each containing 150 (one hundred fifty) bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup "REXLEY-T" Cough Syrup each bottle containing 100 ml having Batch No. ML5430, Mfg date 10/23, Expiry 09/25, MRP Rs. 175/- which was carried by Kamal Biswas (34 yrs) S/O Krishna Biswas of Chowpukuria Kestopur PO+PS Bagdogra Dist Darjeeling and one black colour carry bag each containing 150 (one hundred fifty) bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup "REXLEY-T" Cough Syrup each bottle containing 100 ml having Batch No. ML5430, Mfg date 10/23, Expiry 09/25, MRP Rs. 175/- which was carried by Ranjit Mahato (35yrs) S/O Deb Narayan Mahato of Anchal Gali no 2 Champasri PS Pradhan nagar Dist Darjeeling. On demand in presence of Shri Manish Kumar Yadav, WBPS, ACP Investigation unit, Siliguri Police Commissionerate as well the independent witnesses the detained persons failed to produce any valid documents/papers for possessing of such a huge quantity of 'Codeine Phosphate' based Cough Syrup. On further interrogation they admitted their guilt and stated that they had procured the said 'Codeine Phosphate' based Cough Syrup clandestinely from their supplier for the purpose of selling the same in high rates to their designed customers and also stated that they were waiting for their customer to deliver the same for their personal gain by illegal means. They also disclosed that they have been dealing such type of business of procuring and selling of 'Codeine Phosphate' based cough syrup illegally for last few months for their wrongful gain.

Accordingly, I seized the recovered One black color carry bag containing 150 (one hundred fifty) bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup "REXLEY-T" Cough Syrup each bottle containing 100 ml having Batch No. ML5430, Mfg date 10/23, Expiry 09/25, MRP Rs. 175/- each and marked as Exhibit "A'. From the exclusive and conscious possession of Kamal Biswas (34 yrs) S/O Krishna Biswas of Chowpukuria Kestopur PO+PS Bagdogra Dist Darjeeling and One black color carry bag containing 150 (one hundred fifty) bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup "REXLEY-T" Cough Syrup each bottle containing 100 ml having Batch No. ML5430, Mfg date 10/23, Expiry 09/25, MRP Rs. 175/- each and marked as Exhibit "B' from the possession of Ranjit Mahato (35yrs) S/O Deb Narayan Mahato of Anchal Gali no 2 Champasri PS Pradhan nagar Dist Darjeeling under proper seizure list in presence of in presence of Shri Manish Kumar Yadav, WBPS, ACP investigation unit, Siliguri Police Commissionerate, and independent witnesses and obtain their signature and acknowledged by the accused persons. Subsequently, I sealed and labelled the seized articles in presence of Shri Manish Kumar Yadav, WBPS, ACP investigation unit, Siliguri Police Commissionerate, independent witnesses and the above noted accused persons. The whole process of search, seizure and label was made under the coverage of videography by the videographer named Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling in between 16.10 hrs to 17.25 hrs.

From the above noted facts and seizure of incriminating articles it is quite evident that the following accused persons namely i) Kamal Biswas (34 yrs) S/O Krishna Biswas of Chow Pukuria Kestopur PO+PS Bagdogra Dist Darjeeling and ii) Ranjit Mahato (35yrs) S/O Deb Narayan Mahato of Anchal Gali no 2 Champasri PS Pradhan nagar Dist Darjeeling are involved in procuring and selling 'Codeine Phosphate' based drugs illegally contravening the norms of NDPS Act. Then, I arrested the above noted accused persons namely i) Kamal Biswas (34 yrs) S/O Krishna Biswas of Chow Pukuria Kestopur

PQ+PS Bagdogra Dist Darjeeling and ii) Ranjit Mahato (35yrs) S/O Deb Narayan Mahato of Anchal Gali no 2 Champasri PS Pradhan nagar Dist Darjeelingafter observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the accused persons namely i) Kamal Biswas (34 yrs) S/O Krishna Biswas of Chowpukuria Kestopur PO+PS Bagdogra Dist Darjeeling and ii) Ranjit Mahato (35yrs) S/O Deb Narayan Mahato of Anchal Gali no 2 Champasri, PS Pradhan nagar, Dist Darjeeling and arrange for its investigation.
