Sir,

With due respect, I, Sri. Santosh Sha Jaiswal, full address mentioned above begs to state that, I and my own brother Sri. Kamal Sha Jaiswal are un-employed since many years and finding our pathetic situation Sri. Raju Ram Prasad, S/O. Ramanand Prasad, resident of Village- Harekrishnapally, P.O. & P.S- Bagdogra, Dist.- Darjeeling, approached both of us and said to us that if we pay him Rs.1,60,000=00 (Rupees One Lakhs and Sixty Thousand) then he will get us a supervisor job in Indigo Airlines in Kolkata Airport on monthly salary basis of Rs.17,600=00 each as he has contact there and he has sent many people there for employment.

Finding no employment and no alternative either, we somehow managed to get Rs.1,60,000=00 and gave him the money on various dates starting from 06-12-2019 for employment in Indigo Airlines in Kolkata Airport as supervisors. Raju Ram Prasad made us sign many forms and after a few days both of us also received acknowledgement letters- dated- 19-12-2019 and joining letters- dated- 19-02-2020 from Indigo Airlines through the hands of Sri. Raju Ram Prasad.

But after few days of handing over the joining letters to us, he stated to us not to join now as we will be joining not at Kolkata Airport but to some other Airport as supervisors. But time went by and we did not get any employment from Sri. Raju Ram Prasad. We also went to the house of Sri. Raju Ram Prasad for Rs.1,60,000=00 that we gave him. But
