National Commission for Protection of Child Rights (hereinafter referred to as the Commission) is a statutory body constituted under Section 3 of the Commission for Protection of Child Rights (CPCR) Act, 2005 to protect the child rights and other related matters in the Country. The Commission is further mandated to monitor the proper and effective implementation of Protection of Children from Sexual Offences (POCSO) Act, 2012: Juvenile Justice (Care and Protection of Children) Act, 2015 and Right to Free and Compulsory Education (RTE) Act, 2009. In one of the functions laid down under Section 13 of the CPCR Act, 2005, the Commission has been assigned with the function to examine and review the safeguards provided by or under any law for the time being in force for the protection of child rights and recommend measures for their effective implementation. The Commission also has the powers of Civil Court trying a suit under Section 14 of CPCR Act, 2005 and Code of Civil Procedure, 1908.

- The Commission is in receipt of a complaint wherein it has been alleged that a school child tried to confine his classmate in the school and when the victim child resisted he was beaten up. The matter was reported by the victim minor to his school teachers. Later, the child was again beaten up by the minor for reporting the incident and again the minor reported the incident to the headmaster. The headmaster tried to resolve the matter however, it was not resolved. It has been further alleged that the victim child was restrained while he was returning back to home. Some unknown adult joined with the child to threaten the victim child. (Copy of self-explanatory complaint enclosed)
- In view of the allegations stated in the complaint, the Commission has taken cognizance under Section 13(1)(j) of CPCR Act, 2005 and is of the view that prima-facie it appears to be in contravention of provisions Juvenile Justice (Care and Protection of Children) Act, 2015 and relevant provisions of Indian Penal Code.
- The Commission thereby requests your good offices to inquire into the matter ensuring the safety and 4. security of the minor. Further, an action taken report be submitted to the Commission within 07 days of

incident to his two school teacher namely Mr. Shubendhu sir and Sangram sir. After that the said boy had beaten again to my son as because he reported the incident to his school teachers. Thereafter my son went before the Headmaster of the school namely Utpal sir for informing the said incident. On the basis of the verbal complain of my son, the Headmaster of the school tried to solve the matter. But after coming back from the office of the headmaster, the accused school boy Sonai Sarkar restrained my son on public road for restraining to coming back at my home and repeatedly tried to use force for restraining my son under the leadership of one adult aged unknown person. The unknown person assisted Sonai Sarkar for assaulting my son and the unknown person started threating for kill with mentioning the language that 'your father can not do anything'. He also added in Bengali language that "TOR BABAR KOTO DOM DEKHBO." The unknown person who was wearing blue full shirt and black pant, started beating upon my son with enough force which could have occurred the death of my child. In that circumstance my son just ran away towards his school headmaster's room for escaping the dire consequence when the unknown person tried to abduct from the public road. Thereafter my son took shelter at his school premises and communicated with the school headmaster.

Some facts of this incident recorded via CCTV of the nearest place of the shop of Saptashika Gas Agency, CANARA Bank and BSNL Telephone office. The unknown person had beaten my son in inhuman manner. My son not only affected by physically, but he is now under mental depression due to this incident. Kindly note that, my family members along with my son are now in insecure situation. We are in mental agony due to the above-mentioned incident. We

were waiting till date to get justice from the headmaster of the school for finding ou: the nexus between the said school student and that unknown antisocial person, as the boy is also the student of the same school. But no result had come after waiting reasonable period of time.

I therefore request you, your goodself kindly investigate the above mentioned matter and for the interest of justice, kindly arrest the unknown person who is the culprit for attempting to abduct of my son with intention of murder. Please provide necessary security for my son and my other family members. Kindly lodge an FIR in respect of the aforesaid incident and please ensure the justice as per law of the land.
