In producing herewith one arrested accused person namely Abishek Singh (20) s/o Akhilesh Singh of Tumbajote, Hanumannagar, PO+PS-Matigara, Dist-Darjeeling following seized articles under proper seizure list –

- 1) Three (03) Packets of Matal Big boss chocolate bomb each packet containing 10 pieces. (Total 3x10=30 pieces).
- 2) Nine (09) Packets of Chut Puth green crackers each packet containing 10 pieces (Total 09x10=90 pieces).
- 3) Eight (08) Packets of Jugmug Roll cap each packet containing 100 pieces(Total 9x100=900 pieces).
- 4) Fifty (50) Packets of Maharaja Sparklers each packet containing 10 pieces. (Total 50x10=500 pieces).
- 5) Fifty (50) Packets of RAJKUMARI ELECTRIC SPARKLERS by Mahabir Factory (each packet containing 10 piece), (Total 50x10=500 pieces).
- 6) Forty (40) Packets of Jawan Tintin Electric Sparklers each packet containing 10 pieces. (Total 40x10=400 pieces).
- 7) Five (05) Packets of M.T's Ground Chakkar Special by M.T. Industries each packet containing 10 pieces. (Total 05x10=50 pieces).
- 8) Three (03) Packets of MAA Sitala Flower Pot Giant manufactured by MASI MAA Fire Works each packet containing 10 pieces. (Total 03x10=30 pieces).
- 9) Two (02) packets of Cock Brand Kaliswari Penta Sky Flash manufactured by Sri Kaliswari Fireworks Private Ltd each packet containing 05 pieces. (Total 02x05=10 pieces).
- 10) Five (05) packets of Ground Chakkar Deluxe Green Cracker manufactured by MASI MAA Fire Works each packet containing 10 pieces. (Total 05x10 = 50 pieces).
- 11) Five (05) packets of MAA Sitala Flower Pot Special manufactured by MASI MAA Fire Works each packet containing 10 pieces. (Total 05x10 = 50 pieces).
- 12) Four (04) packets of Puja Special Spinner by Puja Traders each packet containing 10 pieces. (Total 04x10 = 40 pieces).
- 13) Five (05) packets of JIVA Gorund Chakkar Big Green Cracker manufactured by Masi Maa Fire Works each packet containing 25 pieces. (Total 05x25 = 125 pieces).
- 14) Thirty (30) packets of Vaishnavis King Cobra bomb manufactured by Vaishnavi Fireworks, Sivakasi each packet containing 28 pieces. (Total 30 x 28 = 840 pieces).

I, SI Sailesh Subba of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint to the effect that today on 06.11.2023 at 16:05 hrs I received a secret information that one Abishek Singh of Tumbajote has stored huge quantity of Fire-crackers at his house at Matigara Bazaar for selling the same in the open market for his wrongful gain without having any license or any other valid documents in respect of the same. Accordingly informed the matter to Officer incharge and noted the fact in GDE vide GDE No.313, date. 06.11.2023. And as per his kind order I along with SI Agen Lepcha, ASI- Dhirendranath Mondal, C/1053 Paresh Rava, CVF/643 Animesh Roy, CVF/977 Ganesh Paswan all of Matigara PS, SPC rushed to the spot to work out the information.

At about 14.25 hours I along with force reached at Tombajote and contacted with my source and being shown and identified by source we proceeded towards the house and entered and held raid into the house of the of the above noted accused person. Accordingly, I detained one person who disclosed his identity as Abishek Singh (20) s/o Akhilesh Singh of Tumbajote, Hanumannagar, PO+PS-Matigara, Dist-Darjeeling. I, searched his house in presence of local witnesses namely 1] Banty Singha s/o Sabin Kumar Singh of Kholaibhaktrai, PO+PS-Matigara, Dist. Darjeeling and 2] Bimal Kumar Roy s/o Bishal Roy of Tumbajote, Near Biscuit factory, PO+ PS Matigara, Dist. Darjeeling and found the above noted seized articles being stored in his house without any precautionary and safety measures. On demand he could not produce any valid documents in respect of seized banned firecrackers. Thus violating the provision of law which may endanger human life and likely to cause injury of human life.

There is a reason to believe that the apprehended accused person namely Abishek Singh has stored huge quantity of banned fire crackers for selling the same in the open market for his wrongful gain, which are combustible in nature and endanger to human life and property at his house illegally and violating Govt. Orders. Moreover, the above noted banned fire crackers were stored without any precautionary and safety measures and thus, violated the section 285/286 of Indian Penal Code & 24 WBFS Act.

Accordingly, I seized the above noted banned fire crackers under proper seizure list duly signed by the witnesses. The whole process of seizure was made between 16:45 hours to 17:50 hours and arrested the apprehended accused person namely Abishek Singh (20) s/o Akhilesh Singh of Tumbajote, Hanuman Nagar, PO+PS-Matigara, Dist-Darjeeling. Subsequently, I seized the above noted articles after observing all the formalities.

Under the above noted fact and circumstances, I pray before you that a specific case may kindly be started against the accused person namely Abishek Singh (20) s/o Akhilesh Singh of Tumbajote, Hanuman Nagar, PO+PS-Matigara, Dist-Darjeeling under proper section of law and arrange for its investigation.
