Sir,

In producing herewith two arrested accused persons namely (1) Sabir Hussain-45yrs s/o Lt Md Mustafa of Jyotinagar, Jhankar More, Ward No-4 PS Siliguri, Dist Darjeeling and (2) Md Makbul-55yrs s/o Lt Dost Md of Airport More, Maszid para, PS Bagdogra Dist Darjeeling along with following seized articles viz:

- (1) 14 Packets of RAHINO power chocolate firecrackers each packet containing 10pcs, Manufactured by S.S Enterprise Kolkata
- (2) 22 Packets of JUGMUG chocolate junior firecrackers each packet containing 12 pcs
- (3) 93 packets of DELUX king cobra chorsa crackers each packet containing 28 pcs manufactured by Aruna Fireworks industries Sivakasi
- (4) 92 packets of QUEEN cobra electric crackers each packet containing 30pcs from their possession. (Total-09 kgs)

I beg to report that I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complaint against the above noted arrested accused persons to the effect that on 06.11.23 at about 15.05hrs received secret source information from Salugara hat that two persons stored and selling huge quantity of band fire crackers at their street shop at Salugara Hat under Bhaktinagar PS. Diarized the information in GD vide Bhaktinagar PS GDE no-286 dated 06.11.23 and as per your kind instruction myself along with SI Rantu Halder, ASI Dipak Karmakar, ASI Chandra Prakash Adhikary, C/374 Debraj Biswas, CVF/614 Sumit Kumar Roy left for Salugara hat to work out the information.

At about 16.05hrs we reached at Salugara Hat, sometimes after, being identified by the source our police party held raid in the street shop of above noted persons and recovered the above noted articles from their shop. On demand they could not produce any valid documents/license in support of said fire crackers and also stated that they were selling the band fire crackers in their shop without any valid documents or license violating the provision of law which may endanger human life and likely to cause hurt or injury human or property. Accordingly I seized the above noted fire crackers in presence of witness duly signed by them and accused persons from the possession of (1) Sabir Hussain s/o Lt Md Mustafa of Jyotinagar, Jhankar More, Ward No-4 PS Siliguri, Dist Darjeeling and (2) Md Makbul s/o Lt Dost Md of Airport More, Maszid para, PS Bagdogra Dist Darjeeling and arrested them u/s 41 Cr.pc. (The seizure was made in between 16.40hrs to 18.45hrs)

I therefore request you a specific case may kindly be started against the accused persons namely (1) Sabir Hussain-45yrs s/o Lt Md Mustafa of Jyotinagar, Jhankar More, Ward No-4 PS Siliguri, Dist Darjeeling and (2) Md Makbul-55yrs s/o Lt Dost Md of Airport More, Maszid para, PS Bagdogra Dist Darjeeling under proper section of law and arrange for its investigation.
