Sir,

In producing herewith 03(Three) arrested person namely -

1. Babai Roy, S/O- Satyen Roy of Vill- Bharat Nagar, PO+PS- Siliguri, Dist- Darjeeling (Brown Colour Toto) ;
2. Md. Mannan , S/O- Yousuf Ali, of Vill- Kamrangaguri, PO- Satellite Township, PS- Bhaktinagar, Dist- Jalpaiguri (Blue Colour Toto);
3. Dipak Kumar, S/O- Shyam Lal Roy of Vill- Yadav Pally , PO+PS- Siliguri, Dist- Darjeeling. (Red Colour Toto)

Paddler of Toto (E-rickshaw), without number plate, along with their Toto under seizer, I SI(AB) Ranjit Roy of Jalpaimore Traffic Guard, Siliguri Police Commissionerate do here by lodge written complaint against them to the effect that, on 06.11.2023 at from 19:35 hrs to 20.05 hrs I along with ASI(AB) 241 Abu Saleh and C/821 Chinmoy Roy while performing traffic regulation duty at Bardhawan Road, near Shantoshinagar under Jalpaimore Traffic Guard, PS- Siliguri, Dist- Darjeeling found that, the above noted person were plying their Toto (E-rickshaw), as noted above on AH-2 by violating Govt. Order vide **Notification number 1526/1(1)/-WT/3M-56/13/PT.II Dated-27.04.2015 of Principal Secretary to the Govt. of West Bengal** and also disrupting the free flow of traffic by stopping here and there disorderly for collect passengers.

Accordingly, I along with force apprehended them and on asking they could not produce any valid documents nor could able to express any satisfactory reason to do like so. Further asking they stated their name and address as noted above.

Finding no any alternative way I arrested them u/s 41 Cr. P.C and seized their Toto from their possession u/s 102 Cr. P.C by preparing proper arrest memo and seizure list and brought them to Siliguri Police Station for custody.

I, therefore, pray before your kindness that, kindly lodge a specific case in proper section of law against them for violating Govt. order and obstructing for free flow traffic movement and arrange for its proper investigation.
